SUBJECT: GROUP HOME PROGRAM MONITORING REPORT - ETTIE LEE

HOMES, INC., DIAMOND L RANCH, MT. JURUPA, ROBERTSON MEMORIAL HOME, SANTA ANA, AND FONTANA GROUP HOMES

We have completed a review of Diamond L Ranch, Mt. Jurupa, Robertson Memorial Home, Santa Ana and Fontana Group Homes (Group Home or Agency) operated by Ettie Lee Homes, Inc. Each Group Home contracts with the Department of Children and Family Services (DCFS) and the Probation Department (Probation).

Diamond L Ranch Group Home is a nine-bed facility, which provides care for boys ages 10-17 years who exhibit behavioral, social, and emotional difficulties. At the time of the monitoring visit, Diamond L Ranch Group Home was providing services for four Los Angeles County Probation children and one Riverside County child. Diamond L Ranch Group Home is located in San Bernardino County.

Mt. Jurupa is a 12-bed facility, which provides care for boys ages 11-17 years who exhibit behavioral, social, and emotional difficulties. At the time of the monitoring visit, Mt. Jurupa Group Home was providing services for three Los Angeles County DCFS children, and nine Los Angeles County Probation children. Mt. Jurupa Group Home is located in San Bernardino County.

Robertson Memorial Home Group Home is a 12-bed facility, which provides care for boys ages 10-17 years who exhibit behavioral, social, and emotional difficulties. At the time of the monitoring visit, Robertson Memorial Home Group Home was providing services for twelve Los Angeles County Probation children. Robertson Memorial Home Group Home is located in Riverside County.

Santa Ana Group Home is a six-bed facility, which provides care for boys ages 11-17 years who exhibit behavioral, social, and emotional difficulties. At the time of the monitoring visit, Santa Ana Group Home was providing services for one DCFS child, five Los Angeles County Probation children, and one Riverside County child. Santa Ana Group Home is located in Orange County.

Fontana Group Home is a 10-bed facility, which provides care for boys ages 11-17 years who exhibit behavioral, social, and emotional difficulties. At the time of the monitoring visit, Fontana Group Home was providing services for six DCFS children, and two Los Angeles County Probation children. Fontana Group Home is located in San Bernardino County.

Scope of Review

The purpose of the review was to determine whether the Agency was providing the services outlined in their Program Statement. Additionally, the review covered basic child safety and licensing issues, and included an evaluation of the Agency's Program Statement, internal policies and procedures, child case records, facility inspections, and interviews with two children placed in each Group Home at the time of the reviews. Interviews with the residents were designed to obtain their perspectives on the program services provided by the Agency and to ensure adherence to the Foster Youth Bill of Rights.

Summary of Findings

Generally, the Agency was providing the services outlined in their Program Statement. However, the Agency needs to address various areas where improvements are needed. All five Group Homes need to make numerous repairs to the facilities. Diamond L Ranch needs to provide each resident with the opportunity to maintain a photo album/life book. Mt. Jurupa Group Home needs to allow residents to participate in self-selected activities. Robertson Memorial Home Group Home needs to provide initial assessments for each resident; ensure that residents are aware of their ability to participate in self-selected activities; and maintain current court authorizations and document psychiatric evaluations for residents on psychotropic medications. Fontana Home Group Home needs to inform residents of their right to refuse medication.

Attached is a detailed report of the review findings.

Review of Report

We discussed our report with the Agency's management. The Agency's management is required to provide a corrective action plan to the Children's Group Home Ombudsman within 15 business days from the postmark date of this report. We thank the management and staff for their cooperation during our review.

Method of assessment – Observation

Sample size for resident Interviews: Two

Comments:

Diamond L Ranch Group Home is located in a residential community in Bloomington. The overall condition of the home is adequate. There were no observable safety hazards.

The residents' bedrooms are personalized by the residents to reflect their style and tastes. However, the interior of the Group Home needs improvement.

The carpeting throughout the Group Home is stained and dirty. Tile flooring throughout the Group Home is damaged and worn and in the kitchen, cabinet doors are missing. In the bathrooms, the showers are dirty and have a build up of soap scum. There is gang writing etched on the bathroom doors and walls, and the toilet bowls and seats are dirty. In the TV room, the area rug is stained, the couches are stained with torn seat cus hions and arm rests, and the screens are hanging off the windows.

The walls in all of the residents' bedrooms are dirty and paint is chipped off the walls and closets. In bedrooms numbers one and three, door knobs are missing from the doors. In bedroom number five, the mini blinds are missing slats.

The Group Home maintains age-appropriate and accessible recreational equipment. There are also board games, a TV, and a VCR/DVD player. Books and resource materials, including a computer with a variety of programs, are also available.

There is a sufficient supply of frozen food, meat, canned goods, bakery items, and fresh fruit. The food is accessible and appropriately dated.

Recommendations

- 1. Ettie Lee Homes, Inc. management:
 - a. Replace the carpeting and tile flooring throughout the Group Home.
 - b. Replace the kitchen cabinet doors.
 - c. Clean the residents' bathrooms.
 - d. Remove writing from the bathroom doors.
 - e. Clean TV room area rug.
 - f. Clean and repair the TV room couches.
 - g. Replace window screens.
 - h. Clean and repaint the walls and closets throughout the Group Home as needed.
 - i. Replace door knobs in bedroom numbers one and three.
 - j. Replace the mini blinds in bedroom number five.

Recommendations

They reported that there is sufficient staff supervision and expressed satisfaction with the quality of their interactions with staff. Residents feel there is at least one staff member they can easily talk to and trust.

Residents reported that they are assigned chores to complete on a daily basis that are reasonable and not too demanding. Residents are able to have visitors and make and receive personal telephone calls. They are permitted to contact their workers, attorneys, and family members as needed. Residents are able to attend weekly religious services of their choice and feel that the Agency is respectful of their cultural lifestyles. The Agency allows the residents to celebrate holidays.

Residents reported that the discipline policies are consistently enforced and that there are fair and appropriate consequences for inappropriate behavior.

The residents are aware of their right to refuse medication.

One resident did not have an opportunity to maintain a photo album/life book.

The walls in all of the residents' bedrooms are dirty and paint is chipped off the walls and closets. In bedrooms numbers one, four, and five, the mini blinds are missing slats. In bedroom numbers two and five, gang writing is etched on the doors and walls.

The Group Home maintains age-appropriate and accessible recreational equipment. There are also board games, a TV, and a VCR/DVD player. There are books and resource materials, however, residents do not have access to a computer.

There is a sufficient supply of frozen food, meat, canned goods, bakery items, and fresh fruit. The food is accessible and appropriately dated.

- 1. Ettie Lee Homes, Inc. management:
 - a. Replace the carpeting and tile flooring throughout the Group Home.
 - b. Clean and paint the walls and closets throughout the Group Home as needed.
 - c. Clean or replace the furniture in the living room and library.
 - d. Repaint the pantry door.
 - e. Clean the residents' bathrooms.
 - f. Replace the mini blinds in bedroom numbers one, four, and five.
 - g. Remove gang writing from the door and walls in bedroom numbers one and five.
 - h. Provide residents with access to a computer.
