GROUP HOMES, INC., LA VERNE, PHILLIPS RANCH, VALINDA AND

WHITTIER SITES

We have completed a review of La Verne, Phillips Ranch, Valinda, and Whittier Group Homes (Group Home or Agency), operated by Heritage Group Homes, Incorporated. Each Group Home contracts with the Department of Children and Family Services (DCFS) and the Probation Department (Probation).

La Verne, Phillips Ranch, and Valinda Group Homes are six-bed facilities, which provide care for boys ages 11-17 years who exhibit behavioral, social, and emotional difficulties. Whittier Group Home is a six bed facility, which provides care for girls ages 13-17 years who exhibit behavioral, social and emotional difficulties. At the time of the monitoring visit, La Verne, Phillips Ranch, and Valinda Group Homes were each providing services for six Los Angeles County DCFS children, and Whittier Group Home was providing services for five Los Angeles County DCFS children.

La Verne Group Home is located in the Fifth District. Phillips Ranch, and Valinda Group Homes are located in the First District. Whittier Group Home is located in the Fourth District.

# **Scope of Review**

The purpose of the review is to determine whether the Agency is providing the services outlined in their Program Statement. Additionally, the review covers basic child safety and licensing issues, and includes an evaluation of the Agency's Program Statement,

"To Enrich Lives Through Effective and Caring Service"

internal policies and procedures, child case records, a facility inspection, and interviews with children placed in the Group Home at the time of the review. Interviews with children are designed to obtain their perspectives on the program services provided by the Agency, and to ensure adherence to the Foster Youth Bill of Rights.

# **Summary of Findings**

Generally, the Agency is providing the services as outlined in their Program Statement. However, each Group Home has deficient areas that need to be addressed. All five group homes need to maintain Needs and Services Plans (NSPs) that are comprehensive, specific, measurable, attainable, realistic, time limited and include short term and long term goals for all children.

LaVerne Group Home needs to repair the bathroom faucet handle; clean or replace the carpet in the children's bedrooms; clean all bedroom ceiling fans; and encourage and assist all children in creating and updating life books/photo albums.

Phillips Ranch Group Home needs to repair the upstairs bathroom sink; clean the kitchen oven; paint a patched area on the bedroom wall; repair/replace the broken recreation equipment; and obtain and maintain current court authorizations for all residents taking psychotropic medication.

Valinda Group Home needs to repair the low water pressure in the children's bathroom sink; clean and/or re-glaze the bath tub in the children's main bathroom; remove all writing from bedroom dressers; and obtain and maintain an adequate supply of extra bed linens.

Whittier Group Home needs to include the child's authorized placement worker as part of the treatment team in the development and implementation of the NSP.

# **Review of Report**

We discussed our report with the Agency's management. In response to the recommendations made in the report, the Agency's management completed a corrective action plan (attached) which we approved. We thank the management and staff for their cooperation during our review.

Overall, children's bedrooms are well maintained. The rooms are clean and orderly, and have age-appropriate personalized decorations. There is adequate furniture, lighting, and storage space. Window coverings and window screens are in good repair. The mattresses are comfortable, and the beds all have a full complement of linens. Children's sleeping arrangements are appropriate. However, the carpet in the children's bedrooms is dirty and stained, and the ceiling fans are dirty.

The Group Home maintains age appropriate and accessible recreational equipment. There are also board games, a TV, and a DVD player. Books and resource materials, including a computer with a variety of programs, are also available.

The Group Home maintains a sufficient supply of perishable and non perishable foods.

## Recommendations

- 1. Heritage Group Homes management:
  - a. Repair the bathroom faucet handle.
  - b. Clean or replace the carpet in the children's bedrooms.
  - c. Clean all bedroom ceiling fans.

  - c. Paint the patched area on the wall in the first bedroom upstairs.

# **Corrective Action Plan**

Pursuant to your review, this letter is in response to the contract audit results of Heritage Group Home V. Generally, we are in agreement with the findings and have put in place the following Corrective Action Plan.

## Recommendation 1:

a) Repair bathroom knob, b) clean or replace carpet and c)clean ceiling fans

## Current Status/CAP:

- a) Bathroom knob on the sink was repaired on 5/17/05
- b) Carpet in children's bedroom has been ordered and will be replaced on
- c) Ceiling fans in children's bedrooms were cleaned on 5/17/05

The facility manager is responsible for maintaining an acceptable level of cleanliness and good repair in the facility. The site Administrator will conduct thorough inspections weekly to ensure compliance in this area.

#### Recommendation 2:

Needs and Service Plans should include long term and short term goals for each child.

# Current Status/CAP:

Needs and service plans now include long term and short goals. This information was generally indicated in the Quarterly Progress Reports but is now included in the NSP

Pursuant to your review, this letter is in response to the contract audit results of Heritage Group Home V. Generally, we are in agreement with the findings and have put in place the following Corrective Action Plan.

#### Recommendation 1:

a) Repair the upstairs bathroom sink, b) Clean the kitchen oven, c) Paint the patched area on the wall in first bedroom, d) Repair/replace broken recreation equipment.

## Current Status/CAP:

All of the repairs listed above have been completed as of 5/19/05 and the broken recreation equipment has been replaced. The facility manager will inspect all equipment on a weekly basis to make sure it is in proper working order and will also ensure that the facility is in good repair with an excellent level of cleanliness. The program Administrator will conduct weekly site inspections specifically looking at these areas for compliance.

#### **Recommendation 2:**

Provide children with current Needs and Service Plans and maintain NSP's that are comprehensive, specific, measurable and include short term and long term goals.

## Current Status/CAP:

A meeting was conducted with the Treatment Team on 5/20/05 to discuss the audit report and plan a strategy that incorporates all the contract requirements for the NSP's. The Case Manager is responsible for ensuring that all NSP's meet the criteria as indicated in the new DCFS contract and audit report. The administrator will review all Needs and Service Plans prior to submission to guarantee that they are accurate, up to date and include all the criteria indicated.

#### Recommendation 3:

Heritage management to obtain and maintain current court authorizations for all residents taking psychotropic medications.

# Current Status/CAP:

All the children placed at Heritage have current psychotropic medication authorizations on file. At times, it has been difficult to obtain such authorizations in a timely manner because the prescribing psychiatrist makes this request of the court directly. The program administrator will make certain that all children who are prescribed psychotropic medication receive an authorization form completed by the doctor and will document efforts to receive the authorization back in a timely manner.
