Re: Final Design Control Board Submittal Pertaining to Exterior Signage Installation for the Archstone Marina Bay Apartments (formerly known as Bay Club Apartments): Marina "Parcel 8," 14015 Tahiti Way, Marina de Ray, CA 90292

Dear Deputy Director Jones:

We have enclosed our proposed exterior signage plans for the Archstone Marina Bay Apartments located on Tahiti Way. As you know, our company is currently performing a major rehabilitation to our Marina Bay Apartments leasehold, pursuant to plans previously approved by your Design Control Board (DCB) and the Department of Regional Planning. This submittal focuses solely on the exterior signage program for the renovated apartment complex. We seek the DCB's final approval of the enclosed signage package at its December 2012 meeting, and look forward to presenting these plans to the DCB and answering any questions the DCB members may have regarding them at the Board's December meeting.

Description of Exterior Signage Program:

The proposed sign program has been designed to meet the functional, aesthetic and marketing needs of the property. Our intent is to create graphic imagery that is a thematic extension of the architectural improvements.

Upon approach to the site, the first sign one encounters is location 1.01 (see enclosed sheet numbers "SP" and "1" for detail). In a modern, iconographic fashion, this sign clearly identifies the site and sets the tone for the typography, colors and materials that are common to all other project sign types. (While proposed colors and materials types for the signs are indicated on the enclosed plans, we will bring representative color chips to the December 2012 DCB meeting; we will also be prepared to discuss the proposed signage illumination type and hours of illumination with the DCB members at the meeting.)

Continuing east on Tahiti Way, one arrives at sign location 2.01 (see enclosed sheet number "2" for detail). Side A of this sign informs oncoming traffic that access to the leasing center requires a left turn into the entry drive. The adjacent

side B of this sign is a project identification graphic that qualifies the directional information of side A.

Realizing there will invariably be some visitors who will miss the entry drive, we will need to repeat the strategic intent of sign 2.01 for those returning to the entry drive after executing a u-turn at the cul-de-sac. The combination of sign locations 2.01, face B, and sign 3.01 accomplishes this task (see enclosed sheet numbers "2," "2.1," and "3" for detail).

After visitors have parked in their designated spaces, they will then be directed to the pedestrian access to the leasing area and other amenities by sign location 5.01 (see enclosed sheet number "5" for detail).

Sign locations 4.01-4.05 are address numerals. As indicated on the enclosed plans, these signs are located at each street facing entry portal to the building and will serve emergency response vehicles as well as visitors.

Description of Temporary Signs:

In addition to the permanent signs described above, we are proposing two temporary sign types. Sign type 6 (see enclosed sheet number "6" for detail) will direct visitors to the garage access to the interim leasing center that will be utilized during the remodeling process.

Sign type 7 (see enclosed sheet number "7" for detail) will direct disabled visitors to their assigned parking area during the construction phase. These signs are required by code and have been submitted to the County of Los Angeles, Building and Safety Division, by the architect on November 8, 2012.

As noted, we will provide the DCB members color chips and additional information regarding illumination for the proposed signs during our hearing presentation. We are anxious to receive the DCB's final approval of the enclosed signage plans at its December 2012 meeting, so that we may be in a position to pull a Building Permit for the signs and commence installation of the signs on the site as soon as we are permitted. Thank you again for your consideration.






