

The 4' x 5' (20 Square foot) Sign (Located on the Side of the Building to the Left of the stairs) referred to on page 1, is a Fluorescent Tube, Internally Illuminated, Sign Box constructed of: .040 Aluminum with a 3/16" Clear Lexan Face covered with digitally printed Vinyl (Royal Blue with White Lettering bordered by Gold and then Black Edge, see page 5). The Returns of the Sign Box are also covered in a Faux Gold Leaf Vinyl. (see Page 4)






