## **1. CALL TO ORDER AND PLEDGE OF ALLEGIANCE**

Chair Kruger called the meeting to order at 9:32 a.m. Chair Kruger asked Commissioner Dougher to lead the Pledge of Allegiance. The Commissioners and staff stood and recited the Pledge of Allegiance.

On April 15<sup>th</sup> the Board of Supervisors appointed Gary Jones to the position of Director. Chair Kruger and the Commission congratulated Mr. Jones on his appointment. Mr. Jones thanked the Commission and reported there are a number of Capital Projects in the works, great changes has been seen in the marina redevelopment and the partnership with lease holders. The Department is working on the County's position to the TMDL clean water regulations. He is also working on revising the Departments Strategic Plan.

## **2. APPROVAL OF MINUTES**

Chair Kruger asked if there was a motion to approve the minutes. **Motion to approve by Commissioner Dupont, seconded by Commissioner Woodell, and unanimously approved.**

## **3. OLD BUSINESS**

None

Commissioner Woodell said the Commission asked staff to provide the unfunded Capital Project with estimated cost. Mr. Kelly responded that the scope for each project has not been identified, and thus it would be improper to provide numbers since cost estimates needs to be reliable.

## **4. NEW BUSINESS**

- A. Briefing on Los Angeles Regional Water Quality Control Board decision on the copper levels in Marina del Rey

Ms. Baker introduced Michael Tripp, the Department Planning Specialist who will provide an overview of the Marina del Rey Harbor Toxic Pollutants Total Maximum Daily Load (TMDL). On February 6<sup>th</sup> the Los Angeles Regional Water Quality Control Board voted to adopt changes to the TMDL. There are two changes that may interest the Commission. The first is a requirement to reduce the amount of copper entering Marina waters by 85 percent within 10 years; the second is to remediate the Marina's sediment by 2029. He discussed the cost of implementing the changes and informed the Commission that the state hearing date had not been announced, but they are accepting comments on the proposed changes until May 13, 2014. The Commissioners inquired about the cause of the sediment pollution and whether it is hazardous. Chair Kruger wanted to know the timeline before it gets to the EPA. She also asked that staff report back to the Commission on the as the item progresses. Mr. Tripp stated that it is expected to go to the State Board this year and then to the EPA, updates will be provided to the Commission when major events take place. Commissioner Sachs asked for a report

on dredging that has occurred in the past and how it compares to the proposed project. Chair Kruger asked for a summary of the ongoing process and what can be done. Mr. Tripp responded that at the moment comments are being collected. The State Board will respond to those comments, then a hearing will likely be held this year for a vote. If the State Board approves the TMDL, it would go to the EPA for their approval. Once this happens it will be an official document. At this time the County is preparing their comments and looking into the next steps. Ideally, a site specific study will be done to determine the actual toxicity level for copper in the harbor. A hull cleaning ordinance is also being prepared, and staff is working to convince the lessees to become certified Clean Marinas. The Department will look into obtaining grants to assist with the conversion to non-copper paints. Ms. Baker asked for clarification on the dredging. Mr. Jones stated that the past dredging was done at the main channel entrance. This proposed project could be harbor wide. Chair Kruger thanked staff for the report and asked to be update periodically.

#### B. DBH beach jurisdiction, operations and revenues

Ms. Baker introduced Carlos Zimmerman, Assistant Division Chief of Facilities and Property Maintenance Division, and Penelope Rodriguez, Manager of Community & Marketing Services Division. They will be presenting information on the Department beach jurisdiction, operations and revenues. She stated that once the information has been provided and the input from the Commissioners has been received. This information will be distributed as a reference manual. Ms. Rodriguez highlighted what was on the PowerPoint. There are pictures of all the beaches that the Department maintains with an outline of what areas they are responsible for. Also, it listed the restrooms, lifeguard towers, and notes on whether an area or restroom belongs to the City. There are several maps, and lists that provide information on which beach is owned by the County and which ones are being maintained by a service contract. Information on which beach we issue permits for, and the ones we do not also the reason why. Information on revenue source and the cost to maintain the beaches. Mr. Zimmerman went through each picture and provided detail information on each one. Commissioner Woodell stated that staff should check the figures on "List of Facts" which shows two different beach acres and suggested getting a new picture for Malibu Lagoon. Ms. Rodriguez provided information on beach expenses and revenues. The Commissioners would like to see the following information added: list the number of fire pits, list unique information about the beaches, a map of the ocean trenches, and pictures of storm water outflows. It was suggested to have the manual in a binder to allow for easy updating, and to have it available online.

### 5. **STAFF REPORTS**

#### A. Ongoing Activities Report

Ms. Baker provided the report. Mr. Kelly discusses how the annual update on climate change provided to the CEO office connects to the grant funding. He stated that all County agencies have to report to the Board on their actions relating to climate change and global warming.

#### B. Beach and Marina del Rey Special Events

Ms. Baker distributed flyers about the Summer Open House at Dockweiler Youth Center. The report received and filed.

### C. Facilities and Property Maintenance Division Report

Report received and file.

### D. Capital Projects Status Report

Mr. Kelly distributed a copy of the letter regarding Broad Beach project and provided an update.

### E. Lifeguard Report

Assistant Chief Steve Moseley reported that the Junior Lifeguard program continues to expand. They are on track with obtaining a vehicle sponsorship with GM to provide all new front line vehicles. He reported there may be a need for additional sponsorship or preferred pricing to replace all other beach vehicles. There has been an increase in activities on the beach. So far this year there has been at least three times the rescues and twice as many medical calls. No reports of shark sightings. Training academy will take place the first week in May. Commissioner Barnes asked if there was any interest from the Commission to join the shark committee and be on the mailing list. The following Commissioners would like to volunteer, Thomas Barnes, Charles Milam, Jeff Sallee and Wayne Powell. For those who may be interested Commissioner Powell provided information on the website [www.watchthewater.org](http://www.watchthewater.org).

## 6. **COMMISSIONER COMMENTS**

Commissioner Woodell congratulated Mr. Jones on his appointment, and commended staff on the Department new website home page. He also had an idea for creating a foundation for LA beaches. He reported that he spoke to Elizabeth Goldstein who is the president of the California State Parks foundation, and wanted to find out if the Commission would be interested in hearing her speak. If there was no objection he will extend an invitation for her to come to the next meeting. It was suggested to hold a meeting at Dockweiler. There is a document on the history of the beaches, and he suggested adding that to the manual and for staff to verify the dates of when the beach was deeded to the County.

Chair Kruger also liked the idea of holding a meeting at Dockweiler, and recommend it take place in May or June.

Commissioner Ward suggested that we limit presentations to 10 minutes.

Commissioner Dagit reported students who have been working on the water quality project are having a poster contest at the Topanga Library on May 28 from 6-8 p.m. for signs that say "Don't Bring Dogs to the Beach".

Item 4A pertains to a presentation on California State Parks Foundation. Our presenter is Elizabeth Goldstein, President of California State Parks Foundation.

**Presenter's Background:**

Ms. Goldstein joined the California State Parks Foundation (CSPF) as president in June of 2004. CSPF has over 130,000 members and is the only statewide organization dedicated to the preservation, enhancement and protection of California's magnificent state park system. A life-long advocate for parks, Ms. Goldstein has 25-plus years experience working specifically in support of parks and historic preservation.

Prior to joining CSPF, she was general manager of the City and County of San Francisco's Recreation and Park Department. While overseeing that department, she initiated a \$400 million capital campaign that oversaw such projects as the rehabilitation of the Conservatory of Flowers, Harding Golf Course, and neighborhood parks throughout the system. Through most of her career she has fostered public/private partnerships. She has worked to improve resources for the park systems she has worked for, and helped improve responsiveness to the general public.

Ms. Goldstein moved to California in 1994. After arriving in San Francisco she served as director of the western office of the National Trust for Historic Preservation. She managed the National Trust programs in Alaska, Arizona, California, Hawaii, Idaho, Nevada, Oregon, Utah and Washington, as well as the U. S. territories of Guam and Micronesia.

Prior to moving to California, Ms. Goldstein also served as regional director of the New York City region of the State Office of Parks, Recreation and Historic Preservation, and as director of planning for the City of New York's Department of Parks and Recreation. She is co-chair of the City Parks Alliance, a board member of the Geneva Office Building and Powerhouse Restoration Project and the Stern Grove Festival Association, former board member of the Angel Island Immigration Station Foundation, and is an honorary member of the New York State American Institute of Architects. She graduated valedictorian from Beloit College.

**BOARD ACTIONS ON ITEMS RELATING TO BEACHES**

On May 13, 2014, the Board of Supervisors approved as amended the revisions to fees and to implement new fees charged by the Department of Beaches and Harbors for facilities and services provided at Marina del Rey and County-owned, controlled or managed beaches, effective May 1, 2013, except for revision to the parking fees, which will become effective upon California Coastal Commission approval; authorized the Director of the Beaches and Harbors to adjust fees related to parking, youth camps and dry storage of trailered boats after considering customer use or to make necessary public accommodations, not to exceed the maximum fees approved by the Board.

Instruct the Director to adjust the proposed fees as below for Fiscal Year 2014-15:

1. Increases for autos at County-owned, operated, or managed beach parking lots shall not exceed \$2.50 per entry above the existing fees;
2. Increases for autos at County-owned, operated, or managed parking lots in Marina del Rey shall not exceed \$2.50 per entry above the existing fee, and keep the existing \$1.00 per 20-minute fee at the Fisherman's Village parking lot; and
3. Increases in the County's Water Awareness, Training, Education and Recreation (WATER) Program shall not exceed \$35 above the existing fee.

DIVISION PROJECT REPORT**

Item 5C on your agenda provides the Commission with a listing of the Department's projects that are either planned or in progress. There were 122 service requests placed with the County's Internal Services Department to perform work that was considered too large for our internal staff to handle. Shown below is a brief list of those projects that exceed \$10,000:

- Installation of a fuel monitoring system at six locations – estimated cost \$166,000
- Fabricate restroom partition doors at Dockweiler – estimated cost \$18,000
- Repair stairs at Sunset Beach – Will Rogers - estimated cost \$200,000
- Replace partitions in the men's and women's restrooms at Manhattan Beach - estimated cost \$23,500
- Repave and stripe Dockweiler parking lots 1 and 2 and the parking lot at 62<sup>nd</sup> Avenue and Pacific - estimated cost \$401,392
- Build concrete block wall for dumpster in the RV Park - estimated cost \$15,000
- Connect water line to restroom at Point Dume - estimated cost \$37,000
- Replace existing transformer at Dockweiler - estimated cost \$23,275
- Roof replacement and repair of privacy screen at Avenue C restroom in Redondo Beach – estimated cost \$76,000

As the fiscal year comes to a close, most of the projects listed above have been completed. The current status of these projects is shown below:

**Fuel Monitoring System - Six Locations - \$166,000**

An electronic fuel access and monitoring system (Fuel Focus) is being installed at each beach maintenance service yard that will eliminate the current paper-based system and allow staff to print reports of usage and to monitor deliveries.

Status: The project is still ongoing. There are two locations that remain to be completed.



**Fabricate Restroom Partition Doors at Dockweiler - \$18,000**

This project includes removing existing damaged partition doors and installing swirled finish 20-gauge stainless steel partitions, and doors with high security hardware and continuous hinges for added protection against vandalism.

Status: The project is 75% complete.

**Repair Stairs - Sunset Beach – \$200,000**

This project will repair a wooden stairway near Sunset Boulevard and PCH that was damaged in a vehicle accident. The improvements will repair structural damage caused by the accident and replace other structural elements that have decayed and rusted due to the salt air environment and high surf.

Status: Architectural drawings are being completed. The repair is expected to begin within the next fiscal year.

**Replace Partitions in the Men's and Women's Restroom - Manhattan Beach - \$23,500**

This project includes removing existing damaged partition doors in both the men's and women's restroom at Marine Ave., and installing swirled finish 20-gauge stainless steel partitions and doors with high security hardware and continuous hinges for added protection against vandalism.

Status: **Completed.**

**Repave and Restripe Parking Lots 1, 2 and 62<sup>nd</sup> Avenue - Dockweiler - \$401,392**

This project includes resurfacing Lot 1 & 62<sup>nd</sup> Avenue and areas in Lot 2 with 2" of new asphalt; improving ADA access, and sealing and restriping both parking lots. New redwood borders will be installed at 62<sup>nd</sup> Ave. to contain the asphalt.

Status: **Completed.**

**Build Concrete Block Wall for Dumpster - Dockweiler RV Park - \$15,000**

This project includes adding a new dumpster enclosure to the RV Park. The improvement will assist in keeping the RV Park more sanitary during heavy-use periods.

Status: **Completed.**

**Connect Water Line to Restroom - Point Dume - \$37,000**

This project will complete the water line replacement project from last year and includes tying the new water line into the old connections at each of the three restrooms. A high-

grade water system will be used that is designed to last for many years. This improvement will eliminate the waterline breaks that have occurred during the past few summer seasons.

Status: **Completed.**

**Replace Existing Transformer - Dockweiler – \$23,275**

The existing transformer is leaking oil and is likely to cause a power failure to the entire rear row of the RV Park. The new transformer was recently received by the contractor and should be installed by April 4<sup>th</sup>. The expected shut down of the Park should be minimal and not last more than a few hours.

Status: **Completed.**

**Roof Repair and Privacy Screen – Avenue C - \$76,000**

This project involved replacing the roof of the joint lifeguard station and public restroom building, which resulted in lead and asbestos abatement and the installation of new clay tile. A wood privacy screen was also added to the restroom and a bird walk for the lifeguard's portion of the building to aid them in washing their windows.

Status: **Completed.**

Item 5D on your agenda provides the Commission with a status report on the Department's four beach capital projects and other projects of interest.

### **CAPITAL PROJECTS**

#### Supervisory District 3

(1)	Will Rogers State Beach - Coastline Drive Development	\$ 9,512,000
(2)	Dan Blocker-West Improvement Project	5,500,000
(3)	Beach Restroom Septic System Replacement Program	13,788,000
(4)	Surfrider Beach Tank Preservation	<u>529,000</u>
<b>TOTAL</b>		<b>\$29,329,000</b>

#### (1) Will Rogers State Beach – Coastline Drive Development

The project includes: reconstruction of the parking lot; construction of an engineered seawall and slope; removal of the existing wooden pilings to below grade; construction of a view deck and ADA-compliant beach access ramp; and landscaping, irrigation and security lighting improvements.

**Status:** Construction is ongoing and on schedule. Construction is about 60% complete. Completion expected October 2014.

#### (2) Dan Blocker Beach-West Improvement Project

The project involves the development of an unimproved westerly portion of this beach site, all of which will be ADA-compliant and includes a small paved parking lot; restrooms; bluff top trail; benches and picnic facilities with protective railings; new perimeter fencing; and bluff top and slope native planting, with minimal irrigation for erosion control.





*Status:* Construction began on May 5, 2014. Work expected to be completed by end of December 2014.

(3) Beach Restroom Septic System Replacement Program

This program consists of replacing septic systems and leach fields at 16 County operated beach locations in the Topanga and Malibu areas. Each project includes the removal of existing septic pumps and tanks and installation of an advanced treatment septic system, including pumps, tanks, telemetry monitoring system, filter pods, and leach field.

*Status:* On June 10, 2014, the City of Malibu approved the administrative coastal development permit (CDP) application for restroom Nos. 2, 7, 8, and 9. The City's Planning Director will issue the administrative CDP after the June 20 appeal period. Construction is anticipated to start after Labor Day weekend.

(4) Surfrider Beach Tank Preservation

The abandoned saltwater concrete tank was uncovered during the storms of 2004-05. This project is to leave the tank in place on the beach. The tank will be filled with slurry to prevent collapse, sealed, and covered with beach sand.

*Status:* Construction was completed on May 15, 2014.

## **OTHER PROJECTS**

Zuma Beach Underpass

The Department maintains the Zuma Beach Underpass, an access road that runs under Pacific Coast Highway to the main entrance to Zuma Beach. The sediment in the adjacent creek causes storm runoff to flow onto the road. The project is to remove the sediment in the creek to restore its capacity.

*Status:* Project on hold pending meeting with the property owner to discuss abating code violation.
