SUBJECT: **THE RESOURCES COMPANY'S EVIDENCE-BASED PRACTICES  
TRAINING FINAL STATUS REPORT – 1/1/2010 to 6/30/2010**

On December 4, 2007, your Board approved a contract (Contract No. 76405) between the Probation Department (Probation) and The Resources Company (TRC) to provide Evidence-Based Practices (EBP) training to Probation staff. The total contract amount after amended in November 2008, was \$439,011. In addition, your Board directed the Chief Executive Officer (CEO), in conjunction with the Auditor-Controller (A-C), to provide quarterly status reports on the progress of TRC in achieving the contract's deliverables.

Your Board also directed the quarterly reports to include: 1) an update on Probation's overall training efforts related to EBP and 2) an update on the number of staff, youth, and community-based organizations (CBOs) that have been trained by TRC on EBP, along with the associated costs. This is our last status report which covers training activity through June 30, 2010, when the contract expired.

**TRC's Contract Deliverables Review Summary**

TRC did not complete all the contract deliverables required during the contract term because Probation suspended the contract due to budgetary concerns. Probation appropriately paid for all contract deliverables that TRC completed. Since the inception of Contract No. 76405 (from December 2007 through June 2010), TRC completed 43 (78%) of the 55 required training sessions covering 25 topics. Approximately 705

attendees completed the training (Attachment I). Probation paid TRC \$349,865 (72%) of their total contract amount of \$489,011.

### **Probation's Overall EBP Training Efforts**

Probation conducted a total of 84 EBP training sessions from January 2010 through June 2010. Approximately 1,700 Probation managers and staff attended the training. The sessions covered 24 different EBP topics (Attachment II). We reviewed the sign-in sheets for 10 (12%) of the 84 training sessions and confirmed that the number of attendees reported in Probation's training records matched the numbers listed on the sign-in sheets.

Overall, since December 2007, Probation conducted a total of 444 EBP training sessions that 7,875 staff from Probation attended (Attachment III).

From January 2010 through June 2010, Probation also provided training to 139 managers and staff from at least 46 different CBOs (Attachment IV). Since January 2006, 1,217 managers and staff from at least 144 different CBOs received training covering 13 different topics (Attachment V).
