NAPA GROUP HOMES

We have completed a review of Eddington and Napa Group Homes (Group Home or Agency) operated by Fields Comprehensive Youth Services, Inc. The Group Home contracts with the Department of Children and Family Services (DCFS) and the Probation Department.

Eddington and Napa Group Homes are each six-bed facilities, which provide care for boys ages 11-17 years who exhibit behavioral, social and emotional difficulties. At the time of the monitoring visit, Eddington Group Home was providing services for three DCFS children, one Probation child, one Riverside County child and one San Bernardino County child. Napa Group Home was providing services for three DCFS children, one Probation child, one Riverside County child and one San Bernardino County child.

Eddington and Napa Group Homes are located in San Bernardino County.

Scope of Review

The purpose of our review is to determine whether the Agency is providing the services as outlined in their Program Statement. In addition, the review covers basic child safety and licensing issues and includes an evaluation of the Agency's Program Statement, internal policies and procedures, child case records, employee records, a facility Board of Supervisors July 17, 2009 Page 2

inspection and interviews with children placed in the Group Home at the time of the review. Interviews with children are designed to obtain their perspectives on the program services provided by the Agency and to ensure adherence to the Foster Youth Bill of Rights.

Summary of Findings

Generally, the Agency is providing the services as outlined in their Program Statement. However, the Agency needs to address a few deficient areas. For example:

- Both Group Homes need to repair and clean several areas throughout the Group Homes.
- Both Group Homes need to develop comprehensive Needs and Services Plans that include short and long term goals and encourage and assist children in creating and updating life books/photo albums.
- Eddington Group Home needs to maintain current court authorization for all children taking psychotropic medications.

Attached is a detailed report of the review.

Review of Report

We discussed our report with the Agency's management. In response to the recommendations made in the report, the Agency's management completed a corrective action plan (attached) which we approved. We thank the management and staff for their cooperation during our review.

I. Facility and Environment

Method of assessment - Observation

Comments:

Eddington Group Home is located in a residential community. The exterior of the Group Home is well maintained. The front and back yards are clean and adequately landscaped.

The interior of the Group Home is well maintained. The common quarters are neat and clean. There is adequate furniture and lighting in the Group Home. The Group Home provides a home-like environment. However, the window blinds in the hallway are damaged and in bathrooms one and two, the caulking is corroded around the bathtubs.

Children's bedrooms are well maintained. The rooms are clean and orderly and have age-appropriate personalized decorations. There is adequate furniture, lighting and storage space. Window coverings and window screens are in good repair. The mattresses are comfortable, and the beds all have a full complement of linens. Children's sleeping arrangements are appropriate.

The Group Home maintains age-appropriate and accessible recreational equipment. There are also board games, a TV and a DVD player. Books and resource materials, including a computer with a variety of programs, are also available.

The Group Home maintains a sufficient supply of perishable and non perishable foods.

Recommendations

- 1. Fields Comprehensive Youth Services management:
 - a. Replace the damaged window blinds in the hallway.
 - b. Re-caulk the area surrounding the bathtubs in bathrooms one and two.

II. Program Services

Method of assessment - Review of relevant documents and interviews

Sample size: Two

Comments:

Children meet the Group Home's population criteria as outlined in their Program Statement. Children are assessed for needed services within thirty days of placement.

The Needs and Services Plans (NSPs) are current and the treatment team develops and implements the NSPs with input from the child. However, the NSPs are not comprehensive and do not include short and long term goals.

Case files reflect adequate documentation to show that children are receiving treatment services.

Recommendation

2. Fields Comprehensive Youth Services management develop comprehensive Needs and Services Plans that include short and long term goals.

Sample size: Two

Comments:

Children are attending school, are provided with educational support and resources to meet their educational needs and are progressing satisfactorily. The Group Home's program includes the development of children's daily living, self-help, and survival skills. Children are provided with opportunities to participate in emancipation and vocational programs as appropriate.

IV. Recreation and Activities

Method of assessment - Review of relevant documents and interviews

Sample size: Two

Comments:

The Group Home provides children with sufficient recreational activities and leisure time. Children are provided with opportunities to participate in planning activities. Children also participate in extra-curricular, enrichment and social activities in which they have an interest. The Group Home provides transportation to and from the activities.

Recommendation

V. Psychotropic Medication

Method of assessment - Review of relevant documents

Comments:

Children are informed about their psychotropic medication, are aware of their right to refuse medication, and medication distribution logs are properly maintained. The children are routinely seen by the prescribing psychiatrist. However, children do not have current court authorizations for the psychotropic medications that they are taking.

Recommendation

3. Fields Comprehensive Youth Services management maintain current court authorizations for children taking psychotropic medications.

VI. Personal Rights

Method of assessment - Interviews with children

Sample size: Two

Comments:

Children are informed about the Group Home's policies and procedures. Children report that they feel safe in the Group Home and are provided with appropriate staff supervision. Children express satisfaction with the quality of their interactions with staff and report that the staff treats them with respect and dignity.

Children report that they are assigned chores that are reasonable and not too demanding. Children are allowed to make and receive personal telephone calls, send and receive unopened mail, have private visitors and attend religious services of their choice.

Children report that the discipline policies are consistently enforced and that there are fair and appropriate consequences for inappropriate behavior.

Children report satisfaction with meals and snacks. Children also receive voluntary medical, dental and psychiatric care.

The Group Home provides children with the required minimum weekly allowance. Children spend their allowances as they choose.

The Group Home provides children with adequate personal care items. However, children are not encouraged and assisted in creating and maintaining photo albums/life books.

Recommendation

4. Fields Comprehensive Youth Services management encourage and assist children in creating and maintaining photo albums/life books.

Children's bedrooms are adequately maintained. The rooms are clean and orderly and have age-appropriate personalized decorations. There is adequate furniture, lighting and storage space. The mattresses are comfortable, the beds all have a full complement of linens, and children's sleeping arrangements are appropriate. However, the carpet is ripped, the walls need painting, and the window blinds are damaged in all three bedrooms.

The Group Home maintains age-appropriate and accessible recreational equipment. There are also board games, a TV and a DVD player. Books and resource materials, including a computer with a variety of programs, are also available.

The Group Home maintains a sufficient supply of perishable and non perishable foods.

Recommendations

- 1. Fields Comprehensive Youth Services management:
 - a. Replace the backsplash on the kitchen stove.
 - b. Replace or repair the carpet in all three bedrooms.
 - c. Paint the walls in all three bedrooms.
 - d. Replace the damaged blinds in all three bedrooms.
