EXTEND AGREEMENTS FOR CONTRACT SECURITY SERVICES ALL DISTRICTS (3 VOTES)

JOINT RECOMMENDATION WITH THE DEPARTMENT OF HEALTH SERVICES THAT YOUR BOARD:

- 1. Extend on a month-to-month basis, until completion of current RFP process and award of new contracts for Agreement Nos. 70695 and 71553 with Inter-Con Security Systems for contract security services at various County facilities and Olive View Medical Center, as outlined in Attachments I and II. Said contracts are due to expire on December 30, 2002.
- 2. Extend on a month-to-month basis, until completion of current RFP process and award of new contracts for Agreement Nos. 70857 and 70858 with Burns International Security for contract security services at various County facilities, as outlined in Attachments III and IV. Said contracts are due to expire on December 30, 2002.
- 3. Authorize the Director of Personnel to extend the existing contracts until completion. It is anticipated that the RFP's for Agreement Nos. 70858 and 71553 will be released on or about October 25, 2002. The RFP's for the remaining Agreement Nos. 70695 and 70857 has an anticipated release date on or about March 31, 2003.

> The aforementioned recommended action will be taken with the concurrence of Inter-Con Security Systems, Burns International Security, the Department of Health Services and the Department of Human Resources-Office of Public Safety.

4. Approve the continued monthly cost of \$297,475 which is included in the Fiscal Year 2002-03 Adopted Budget.

PURPOSE OF RECOMMENDED ACTION

The extension of the four (4) existing contracts for security services at various County facilities and Olive View Medical Center will give the Office of Public Safety the additional time required to adequately conduct and complete the RFP solicitation process and implement the new contracts.

The additional time is necessary due to the new requirements of the County's *Contract Labor/Payroll Violations Assessment Team* that was established by the Chief Administrative Office (CAO) on April 10, 2001. The team's assessment of the labor violations for the larger security companies has taken up to three (3) weeks to adequately investigate.

IMPLEMENTATION OF STRATEGIC PLAN GOALS

The proposed recommendations support the County's Strategic Plan in the areas of *Fiscal Integrity* and *Organizational Effectiveness* and enables the Office of Public Safety to continue to conduct an effective and fair solicitation process on behalf of the County of Los Angeles.

JUSTIFICATION

As indicated above, the CAO established a *Contract Labor/Payroll Violations Assessment Team.* The new requirements and procedures established by the assessment team creates logistical issues for this department related to the fact that we have four security contracts that all expire on December 30, 2002. The assessment team, comprised of representatives from the Chief Administrative Office, Auditor-Controller, and the Department of Internal Services, must intensively review results of the Department's solicitation process that relate to labor code and payroll violations. They must also base their analysis on information provided by the State Labor Commission in order to determine whether to deduct points from the Proposer's evaluation score. The new labor/payroll violation assessment process will add a considerable amount of time to our evaluation process due to the following:

- 1. The County must wait for specific and detailed information from the State Labor Commission on labor code violations for each proposal.
- 2. The assessment team needs sufficient time to intensively review and assess each violation before they can accurately determine points.
- 3. The unsuccessful bidders will be dealing with two entities instead of one in regard to protesting, reviewing their scores and filing appeals, namely, the evaluation committee selected by OPS and the County's assessment team.

Five (5) security contracts were given six-month extensions by your Board on April 16, 2002 and June 18, 2002. The solicitation process for Agreement No. 71336 has been completed since that time, and is scheduled to appear before your Board for recommendation of award to Burns International, Akal Security, and North American Security to provide security services at Martin Luther King, Jr.-Drew Medical Center, Harbor-UCLA Medical Center, et. al., and High Desert Hospital, et. al.

The Office of Public Safety has made every effort to comply with the County's Community Business Enterprise (CBE) Affirmative Action Programs. One such effort taken to facilitate the opportunity for minority and small businesses to participate in the County's contracting process is to take our larger security contracts and divide them into two (2) or three (3) smaller contracts, as we have done with the aforementioned Agreement No. 71336.

The remaining four (4) existing security contracts all expire on December 30, 2002, which creates a significant logistical challenge for our Department in the coordination of the RFP solicitation process and the implementation of the new contracts.

It is anticipated that the RFP's for expiring Agreement Nos. 71553 and 70858 will be released on or about October 25, 2002. The RFP's for the remaining expiring Agreement Nos. 70695 and 70857 have an anticipated release date on or about March 31, 2003.

Furthermore, this Department negotiated new hourly rates with Inter-Con Security Systems and Burns International Security for the aforementioned agreements, which were approved as to form by County Counsel and adopted by your Board on April 16,. 2002 and June 18, 2002. These new hourly rates, as outlined in Attachments V through VIII, are comparable to the current market rates and our new Proposition "A" contracts. Said rates are also in compliance with the County's *Living Wage Ordinance (LWO);* however, the LWO will not be implemented until after these contracts have been resolicited.

In addition, County facilities under Agreement No. 73686 with the now defunct Paige's Security Services, will be incorporated with the RFP for Agreement No. 70858, as well as thirteen (13) new DPSS facility not currently assigned to any Proposition A contract, and will possibly be divided into two (2) separate contracts. All of these facilities are currently assigned to our "as needed" contractors at a higher hourly rate.

FISCAL IMPACT/FINANCING

Funding is included in the Fiscal Year 2002-03 Adopted Proposed Budget; therefore, there will be no additional fiscal impact to the County resulting from the continued implementation of the new hourly rates, at a total monthly amount of \$297,475.

Your Board approved the current contractor's revised hourly rates on April 16, 2002, and June 18, 2002, and those rates will not change.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

The month-to-month contract extensions shall become effective upon the current contracts expiration date of December 30, 2002 and shall remain in effect until each existing contract has been negotiated and implemented as new Proposition "A" contracts.

Furthermore, the current contracts provide for a *Termination for Convenience* clause whereby the Department may terminate upon twenty-four (24) hours written notice to the Contractor, without liability for any services performed after the date of such termination.

IMPACT ON CURRENT SERVICES

Approval of the recommended action will allow the contract security companies to continue their assignments at designated County sites and maintain public safety at our facilities without interruption. Further, the Office of Public Safety will be able to continue the solicitation process for the remaining contracts in a professional and fair manner while maintaining a safe environment for our client departments, County employees, and the public.

CONCLUSION

It is respectfully requested that the Executive Office, Board of Supervisors, return one (1) approved copy of this Board letter and its attachments to the Chief Administrative Officer, County Counsel, Director of Health Services, Auditor-Controller, Director of Personnel, Chief, Office of Public Safety, Affirmative Action Compliance Officer, Director of Internal Services, Director of Public Social Services, Director of Child Support Services, Director of Mental Health, Assessor, Registrar-Recorder/County Clerk, Director of Community & Senior Services, District Attorney, Director of Children & Family Services, and the County Librarian.
