**Renaming of Walnut Creek Trail in San Dimas  
(FIFTH DISTRICT - 3-Vote Matter)**

**IT IS RECOMMENDED THAT YOUR BOARD:**

- 1 Find this contract is categorically exempt under the California Environmental Quality Act ("CEQA).
- 2 Approve the renaming of Walnut Creek Trail in San Dimas to the "Michael D. Antonovich Trail".

**PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION**

Recently, our Department was approached by Mr. Robert L. Jarvis, Parks Services Bureau Mounted Patrol Unit regarding the renaming of the Walnut Creek Trail to the Michael D. Antonovich Trail to recognize the contribution Supervisor Antonovich has made to the County's Trail system and the Supervisor's dedication to addressing the recreation needs of various trail user groups (See Attachment A support letter). In addition, the Department of Parks and Recreation recommends renaming of the trail in honor of the Supervisor for his support and assistance regarding trail issues within the Fifth Supervisorial District.

**Implementation of Strategic Plan Goals**

Approval of this recommendation enhances the Strategic Plan through (Goal Number 1) Service excellence: Provide the public with easy access to quality information and services that are both beneficial and responsive; as well as (Goal number 6) Community Services: Improve the quality of life for the residents of Los Angeles County's unincorporated communities by offering a wide range of Department-coordinated services responsive to each community's specific needs.

**FISCAL IMPACT/FINANCING**

The only costs associated with the renaming of the trail are those to produce and install approximately fifteen (15) trail marker signs at a total cost of \$1,500. The Department's 2002-03 adopted budget includes sufficient funding for these costs.

**NEGATIVE DECLARATION/ENVIRONMENTAL IMPACT REPORT**

The approval of the renaming of the trail is categorically exempt under the California Environmental Quality Act (CEQA) according to Section 15061 (b)(3) because it can be seen with certainty that this action will have no significant effect on the environment.


**IMPACT ON CURRENT SERVICES AND PROJECTS**
