Dear Supervisors:

We are pleased to inform you that, as of September 30, we have begun providing free, 30-day pet healthcare coverage as part of our animal adoption program for persons who adopt pets from our shelters.

While our agency inoculates all dogs and cats housed at our shelters immediately upon arrival, the healthcare shots we administer may not be effective if the animal is already sick. Since, in many cases, dogs and cats show no signs of illness as the diseases they have are dormant for two weeks or more, our agency has no way of knowing what undiagnosed problems these animals may have.

In the past, we have gotten occasional complaints from persons adopting pets that, within a few days of arrival at their new homes, were showing symptoms, including parvovirus or distemper, to which they may have been exposed prior to being housed at our shelters.

Those pet owners had the choice of returning the ill animal back to us or paying for sometimes expensive veterinary medical care treatment for their newly adopted dogs and cats.

Now, thanks to the animal health insurance coverage program provided by the ShelterCare Pet Insurance Co., new pet owners will have the first 30 days of healthcare coverage provided free of cost.

The free program has a \$500 coverage ceiling, which is a realistic amount for the most common and troublesome communicable pet diseases, including respiratory tract infections (kennel cough), ear infections, skin problems, parvovirus in dogs and panleukopenia in cats.

The coverage also includes removal of foreign objects swallowed by dogs and cats, ingestion of poison and broken bones caused by accidents. Pet owners have the option of extending the start-up 30-day coverage at their own expense.

This program gives new adopters added comfort in knowing they have a free support system to help defray the initial healthcare costs of their new pets. Providing this resource to adopters should increase our customer satisfaction and boost our adoption rates, as well.
