SUBJECT: **EXECUTION OF NEW COMMUNITY HEALTH PLAN STANDARD
FORM AGREEMENTS**

This is to advise you that the Department of Health Services (DHS or Department) is exercising its delegated authority, approved by your Board on June 15, 2004 and December 14, 2004, to offer and execute standard form agreements for the Medi-Cal Managed Care Program/County Temporary Employees Program (MMCP/CTEP) and the Healthy Families Program (HFP) with Board-approved qualified providers, subject to review and approval by County Counsel.

In October/November 2004, Tenet Healthsystem Hospital, Inc. (Tenet) sold three of its wholly-owned hospitals that provide medical services to Community Health Plan (CHP) members. In order for the CHP to provide its members continued access to medical services, the Department has offered and will execute Agreements with the new hospital owners and their respective affiliated Medical Groups/Independent Physician Associations.

In addition, the Department also offered new Agreements with HealthCare L.A., Omnicare Medical Group, St. Francis Hospital Medical Center, and Valley Presbyterian Hospital to improve access for CHP members. These new Agreements are unrelated to the Tenet replacement process.

Attached is a listing of CHP MMCP/CTEP and HFP Agreements.

The standard form agreements used for both the MMCP/CTEP and HFP have been reviewed and approved as to form by County Counsel.
