 An informational letter was distributed to all licensed physicians and laboratory directors within the county on May 25, 2006. It advised them that West Nile virus (WNV) is now enzootic in Los Angeles County (LAC) and California, so all cases of viral meningitis, encephalitis, acute flaccid paralysis, and suspected WNV fever should be tested for WNV and other arboviruses. Free testing for arboviral infections is available through the LAC Public Health Laboratory.

To improve health through leadership, service and education.

- Four medical centers located in areas deemed to be at high risk for WNV-related human illness have agreed to participate in enhanced surveillance of encephalitis and viral meningitis during the WNV season.
- ACDC staff will be meeting regularly with local mosquito abatement district staff and participate in the Regional West Nile Virus Task Force. ACDC also participates in statewide WNV surveillance activities and conference calls.
- ACDC will update the website with WNV-disease related activity as it develops. See http://lapublichealth.org/acd/vectorwestnile.htm.

Our presentation on WNV prevention for the general public was updated and the Office of Organizational Development and Training is conducting training of district public health staff to enable them to give community presentations.
