We respectfully request that you place on the August 8, 2006, Board of Supervisors agenda a presentation to a leading Los Angeles County Certified Farmers' Market Manager. We would also appreciate your directing that a scroll be produced for that presentation.

We sponsor and manage a "Certified Farmers' Market on the Civic Center Mall" each year in August. Begun in 2001, the event celebrates National Farmers' Market Week and serves to promote certified farmers' markets in Los Angeles County, the largest population of such markets in any California county

In celebration of this year's event, we wish to acknowledge the steadfast dedication to direct marketing exhibited by Ms. Pompea Smith, who operates five successful and popular markets and who has, as you know, been working with your office in the establishment of a new market to serve the East Los Angeles community.

We suggest the language of the scroll be:

In appreciation of her many years of dedicated service to the Certified Farmers' Market Program, the County of Los Angeles recognizes Pompea Smith.

Whereas, Pompea Smith has worked diligently this year to establish a new certified farmers' market to bring more farm-fresh produce to the communities of East Los Angeles; and

Whereas, she was instrumental in starting the "Bring the Farm to School" Program, in cooperation with the Los Angeles Unified School District Nutrition Network, to teach children about agriculture, its value and necessity, and the sources of their food; and

Whereas, she has spent four years been teaching food and nutrition to adults through grants from Kaiser Permanente and the California Department of Health Services; and
