PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION:

Approval of the recommended action allows the Department of Health Services (DHS or Department) to extend the term for an additional three months with month-to-month automatic renewals through June 30, 2007. The extension

will allow the Department to continue to receive revenue generated and also additional time to complete a Request for Proposals (RFP) process. Failure to secure the recommended amendment could result in losses of forecasted revenue negatively impacting DHS' budget.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS:

On June 15, 1999, the Board approved a sole-source agreement with California Reimbursement Enterprises, Inc. (CRE), through June 30, 2000, for the provision of Secondary Revenue Identification, Development and Recovery Services, with provisions for two one-year automatic renewals through June 30, 2002.

On February 12, 2002, the Board approved Amendment No. 1 to add provisions to exclude Medi-Cal cost report settlements from being a basis on which CRE is paid and to reduce outpatient Medi-Cal contingency fees payable to CRE as a result of implementation of the 1115 Waiver Cost Based Reimbursement Clinics (CBRC).

On December 3, 2002, the Board approved Amendment No. 2 to extend the term for an additional six months, with provision for automatic renewal for a maximum of three additional fiscal years, from July 1, 2003 through June 30, 2006. It also delegated authority to the Director to extend the term of the Agreement on a month-to-month basis, for a period not to exceed six months through December 31, 2006.

On March 18, 2003, the Agreement was amended (Amendment No. 3) to add The Health Insurance Portability and Accountability Act of 1996 (HIPAA) Business Associates provision.

Amendment No. 4 will allow the Department sufficient time to complete the RFP process.

Exhibit I has been approved as to form by County Counsel.

CONTRACTING PROCESS:

This amendment is for an extension of a sole source Agreement. The Department is requesting approval to extend the Agreement to complete a Request For Proposals competitive solicitation process, anticipated for release in early 2007.

IMPACT ON CURRENT SERVICES (OR PROJECTS):

Approval of the recommendation ensures that the financial recovery services currently provided by CRE will continue uninterrupted through June 30, 2007.

REQUESTED ACTION:

Approve and instruct the Director, or his designee, to sign Amendment No. 4 to the SRIDRS Agreement with CRE County (Contract No. H-207263), to extend the term for an additional three months, effective January 1, 2007 through March 31, 2007, with provisions for automatic renewals on a month-to-month basis through June 30, 2007, to complete a solicitation process.

PROGRAM:

The SRIDRS provides a back-up or "safety-net" function after the County's own collection efforts and the subsequent efforts of its primary contractors have been exhausted.

CONTRACT AMOUNT:

Fiscal Year (FY) 2005-06 CRE collections totaled \$14.8 million; fees paid to CRE totaled \$3.8 million, and it is estimated that collections and fees for FY 2006-07 will be comparable to FY 2006-07. Funding to pay the contingency fees is included in the Fiscal Year 2006-07 Final Budget.
