SUBJECT: **QUALIFICATION PROCESS FOR THE
PROVISION OF COUNTYWIDE HOME HEALTH
AND HOSPICE SERVICES**

This is to advise your Board that the Department of Health Services (DHS) intends to release a Qualification Process (QP) to select qualified providers that are best able to provide home health and hospice services.

The QP will be used to replace existing contracts for these services which are slated to expire on March 31, 2007. DHS anticipates filing a recommendation to extend the existing contracts for the March 13, 2007 Board Agenda to allow additional time to complete the QP process.

Attached for your information are the Notice of Intent to Release the QP (Attachment I), and the list of prospective proposers (Attachment II). DHS anticipates submitting a recommendation to the Board in August 2007 for the new contracts to be effective on September 1, 2007.

DHS plans to advertise the QP on the County of Los Angeles Website, <http://ladhs.org/cg/> and in local newspapers, beginning February 20, 2007.
