REQUEST TO APPROVE AN APPROPRIATION ADJUSTMENT FLOOD CONTROL DISTRICT FUND CAPITAL PROJECT (C.P.) 88902 SUPERVISORIAL DISTRICT 5 4 VOTES

IT IS RECOMMENDED THAT YOUR BOARD:

Approve the enclosed Request for Appropriation Adjustment in the amount of \$1,484,000 to transfer funds from the Flood Control District Fund C.P. 88902 to the County Engineer Fund.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The requested action will transfer the canceled commitments of the Flood Control District's C.P. 88902 - Phase 4 Public Works Alhambra Headquarters Refurbishment of the Building and Safety Division. These funds will be utilized to offset the cost for services provided within the County Engineer Fund. These costs increased due to recent Memorandum of Understandings as well as as-needed service contracts.

As approved by your Board in March 2003, County Engineer funds were transferred to the Flood Fund to be used to refurbish existing Building and Safety offices as part of Phase 4 of the Public Works Alhambra Headquarters Refurbishment. However, in conjunction with the CAO, Public Works is now currently pursuing separate construction and financing of a new facility at Public Works' Alhambra Headquarters site. This new facility will accommodate Building and Safety staff, among others. Therefore, the Phase 4 Refurbishment funding will no longer be used as previously planned and, with your Board's approval, will be applied to the County Engineer Fund current operating costs.
