#### IT IS RECOMMENDED THAT YOUR BOARD:

Approve Amendment No. 1 to the Memorandum of Understanding (MOU) for Bargaining Unit 222, Supervising Paramedical Health.

# PURPOSE/JUSTIFICATION OF THE RECOMMENDED ACTION

The Successor MOU for Bargaining Unit 222 has been ratified by the employee organization for a three-year term covering the period of October 1, 2006, through September 30, 2009. The recommended action to implement Amendment No. 1 for Unit 222 is necessary to ensure parity with three (3) newly created non-supervisory classes in the Respiratory Care Practitioner (RCP) Group.

## Implementation of Strategic Plan Goals

The recommended action supports the County's Strategic Plan Goal of Workforce Excellence by correctly reflecting the terms of the MOU.

### FISCAL IMPACT/FINANCING

This recommendation is within the parameters established by your Board. The County's pension actuary, Buck Consultants, has advised that the proposed salary adjustment exceeds LACERA's current assumptions regarding salary inflation and will result in an increase in actuarial liability. THIS AMENDMENT NO. 1 to the Memorandum of Understanding, made and entered into this 3rd day of July, 2007,

WHEREAS, on the 21<sup>st</sup> day of November, 2006, the parties entered into a Memorandum of Understanding regarding the Supervising Paramedical Health Employee Representation Unit, which Memorandum of Understanding (MOU) was subsequently approved and ordered implemented by the County's Board of Supervisors; and

WHEREAS, as a result of mutual agreement, the parties desire to amend the MOU as set forth hereafter:

NOW, THEREFORE, the parties agree as follows:

- Amend Article 52 Salaries; to reflect negotiated salary increases for the classifications as appended hereto, necessitated from a reclassification of classifications reporting to the classifications as appended hereto, to maintain superior subordinate salary differential,

This Amendment No. 1 to said Memorandum of Understanding constitutes a mutual recommendation to be jointly submitted to the County's Board of Supervisors and this Amendment No. 1 will be effective when and if approved by said Board of Supervisors in the same manner provided in Article 5, which was applicable to the implementation of the original Memorandum of Understanding.
