SUBJECT: AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 104 Amendments to existing Legal Entity (LE) Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), and Clinical Assessment programs processed in the month of April, as follows:

- 1. Amendment No. 1 (DMH-02445) with Outlook Associates, LLC** reduces Mental Health Services Act (MHSA) funding in the amount of \$322,573 for the provision of consulting services related to the Integrated Behavioral Health Information System Project. Revised Maximum Contract Amount (MCA) for Fiscal Years (FYs) 2007-08 and 2008-09 will be \$977,002.
- 2. Amendment No. 2 (MH010023) with University of Southern California** adds new agreement language such as Suspension of Payments, Budget Reductions, Payment, Performance Standards and Outcome Measures, and revised agreement language such as Compliance with Applicable Law and Alteration of Terms. There is no change to the MCA.
- 3. Amendment No. 3 (MH010054) with The Regents of the University of California, Los Angeles (UCLA)** replaces Addendum E with Addendum E-3. Addendum E-3 extends the term of services and funding for MHSA Integrated Services for Co-Occurring Mental Health and Substance Abuse Disorders Training and Curriculum Development Program. There is no change to the MCA.
- 4. Amendment No. 4 (MH010054) with The Regents of the University of California, Los Angeles (UCLA)** replaces Addendum F with Addendum F-4. Addendum F-4 aligns the payment procedure with services. There is no change to the MCA.

5. **Amendment No. 3 (MH050011) with California Mental Health Directors Association (CMHDA)** revises Exhibit B-2 (Fee Schedule) to reflect the intent of the original FY 2007-08 Supersession Agreement. It adds County General Funds (CGF) by \$32,000 and adds Paragraph 48 (Local Small Business Enterprise Preference Program) to the Agreement. The revised MCA will be \$192,700.
6. **Amendment No. 2 (MH050019) with Mental Health America of Los Angeles (Consultant Services Agreement)** adds MHSA funding in the amount of \$104,000 for Peer Support Training and \$85,000 for the Mental Health Education/Advocacy Conference. The revised MCA will be \$1,135,000.
7. **Amendment No. 2 (MH120153) with Counseling4Kids** increases cost reimbursement provisional rates for Mental Health Services (MHS) (Mode 15, Service Function Codes (SFCs) 10-19/30-59) from \$2.15 to a new rate of \$2.25 and Medication Support (Mode 15, SFCs 60-69) from \$2.62 to a new rate of \$4.20. There is no change to the MCA.
8. **Amendment No. 7 (MH120172) with Prototypes, Centers for Innovation in Health, Mental Health and Social Services** adds a satellite service delivery site under existing Provider Number (PN) 7370 located at 40 North Altadena Drive, 1B, Pasadena, CA 91107. Services to be provided at this site are Targeted Case Management Services (TCMS) (Mode 15, SFCs 01-09), MHS (Mode 15, SFCs 10-19/30-59), Medication Support (Mode 15, SFCs 60-69), Crisis Intervention (Mode 15, SFCs 70-79), Mental Health Promotion (Mode 45, SFCs 10-19), Community Client Services (Mode 45, SFCs 20-29), and Client Supportive Services (Mode 60, SFCs 64/70-79). It also deletes Day Rehabilitation: Full Day (Mode 10, SFCs 95-99) under existing PN 7370. There is no change to the MCA.
9. **Amendment No. 1 (MH120216) with El Dorado Community Service Center** moves one of the contractor's service sites from 8346 Beverly Blvd., Los Angeles, CA 90048 to 5015 West Pico Blvd., Los Angeles, CA 90019. There is no change to the MCA.
10. **Amendment No. 10 (MH120255) with Special Service for Groups (SSG)** adds a new service provider, SSG-Children's Hospital, Subcontractor, providing services at the new service delivery site located at 5000 Sunset, 4th Floor, Los Angeles, CA 90027. Services to be provided at this site are TCMS (Mode 15, SFCs 01-09), MHS (Mode 15, SFCs 10-19/30-59), Medication Support (Mode 15, SFCs 60-69), Crisis Intervention (Mode 15, SFCs 70-79), Mental Health

Promotion (Mode 45, SFCs 10-19), and Community Client Services (Mode 45, SFCs 20-29). For FY 2007-08 MHSA funds for Full Service Partnership (FSP) – Transitional Age Youth (TAY) will be increased by \$146,084 and for FY 2008-09 it will be increased by \$350,600. The revised MCA for FY 2007-08 will be \$26,161,760 and \$26,263,812 for FY 2008-09.

11. **Amendment No. 4 (MH120257) with St. Anne's Maternity Home** deletes Subcontractor, St. Anne's Maternity Home – Child Development Institute, and services provided under PN 7666. There is no change to the MCA.
12. **Amendment No. 1 (MH120259) with St. John's Hospital and Health Center** decreases SB 90 (AB 3632-SEP) in the amount of \$50,000 and AB 3632-SEP (SB 1807) in the amount of \$69,829. The revised MCA will be \$2,366,471.
13. **Amendment No. 1 (MH120284) with USC Care Medical Group, Inc.**, reflects the mutually-agreed upon provision of funding the one-time expenditure of recruiting, hiring, and training staff for service delivery and necessary equipment required to implement the MHSA Urgent Care Program. It will shift MHSA Urgent Care funds in the amount of \$729,607 to the provision of MHSA One-Time Cost expenditure. There is no change to the MCA.
14. **Amendment No. 1 (MH120286) with JWCH Institute, Inc.**, replaces an existing site located at 555 South San Pedro, Los Angeles, CA 90013 with a new service delivery site located at 515 East 6th Street, Los Angeles, CA 90013. Services to be provided at this site are TCMS (Mode 15, SFCs 01-09), MHS (Mode 15, SFCs 10-19/30-59), Medication Support Services (Mode 15, SFCs 60-69), and Crisis Intervention (Mode 15, SFCs 70-79). There is no change to the MCA.
15. **Amendment No. 1 (MH160080) with San Fernando Valley Community Mental Health Center, Inc.**, adds a service site located at 5519 Elmer Avenue, North Hollywood, CA 91601 to provide Residential Services (Mode 05, SFCs 60-64).
