SUBJECT: **NOTICE OF INTENT TO SUPPLEMENT: HIV/AIDS HEALTH EDUCATION RISK REDUCTION SERVICES – TARZANA TREATMENT CENTER, CONTRACT NUMBER H-700887, SCHEDULES 14 & 15; SPECIAL SERVICE FOR GROUPS/ASIAN PACIFIC AIDS INTERVENTION TEAM, CONTRACT NUMBER H-700891, SCHEDULES 11 & 12; COMMON GROUND, CONTRACT NUMBER H-700895, SCHEDULES 8 & 9; IN THE MEANTIME, CONTRACT NUMBER H-700867, SCHEDULE 4; THE WALL LAS MEMORIAS, CONTRACT NUMBER H-700862, SCHEDULES 8 & 9; CALIFORNIA STATE UNIVERSITY LONG BEACH/CENTER FOR BEHAVIORAL STUDIES, CONTRACT NUMBER H-700938, SCHEDULE 4; LOS ANGELES GAY AND LESBIAN CENTER, CONTRACT NUMBER H-700893, SCHEDULE 18; AND CRI-HELP, INCORPORATED, CONTRACT NUMBER H-700987, SCHEDULE 4**

This is to advise you that the Department of Public Health’s Office of AIDS Programs and Policy will be implementing the fifteen percent provision of the subject agreements. The provision allows the Director of Public Health or his designee authorization to augment services and allocations up to fifteen percent of the contract’s budget.

We will authorize augmentations to the following contracts in the amount of \$20,000 each:

- Tarzana Treatment Center, Contract No. H-700887, increasing the total maximum obligation of the contract to \$715,512.
- Special Services for Groups/Asian Pacific AIDS Intervention Team, Contract No. H-700891, increasing the total maximum obligation of the contract to \$951,308.
- Common Ground, Contract No. H-700895, increasing the total maximum obligation of the contract to \$170,000.
- In the Meantime, Contract No. H-700867, increasing the total maximum obligation of the contract to \$748,260.
- The Wall Las Memorias, Contract No. H-700862, increasing the total maximum obligation of the contract to \$611,148.

- California State University Long Beach/Center for Behavioral Studies, Contract No. H-700938, increasing the total maximum obligation of the contract to \$761,720.
- Cri-Help, Incorporated, Contract No. H-700987, increasing the total maximum obligation of the contract to \$212,388.

These funds will enable the agencies to enhance and expand existing community prevention activities aimed at reducing methamphetamine use and related problems in local communities throughout the County.

Additionally, we will authorize an augmentation of \$33,400, with Los Angeles Gay and Lesbian Center, Contract No. H-700893, increasing the total maximum obligation of the contract to \$2,260,168. These funds will enable the agency to provide expert technical assistance and training to community service providers around crystal methamphetamine treatment and prevention.

The augmentation will be effective from March 1, 2008, through February 28, 2009. Funding is one-time-only and will be obtained from Net County Cost.

If you have any questions or need additional information, please let me know. Unless we hear otherwise, the augmentation will be implemented within two weeks of the date of this letter.
