SUBJECT: **FUNDING AUGMENTATION FOR ARMS OF GRACE HUMANITARIAN SERVICES, INC, CONTRACT NO. PH-000489**

This is to inform you that we plan to amend the County estimated maximum obligation and corresponding maximum allocation for Arms of Grace Humanitarian Services, Inc., using the delegated authority granted by the Board on June 10, 2008 (Board Agenda Synopsis #31). This agency's agreement provides flexibility to adjust funding allocations, and contains provisions that authorize the Director of Public Health or his designee to make such funding changes.

I am recommending this funding increase based on the Sobky v. Smoley court litigation which allowed agencies to request additional funds to cover persons eligible for Drug/Medi-Cal services. The current and proposed funding amount is indicated in the following attachments:
