#### 2009 VOLUNTEER HOURS AND 2010 AWARDS LUNCHEON ON APRIL 12, 2010

The County of Los Angeles benefited from the efforts of 37,654 volunteers last year, who donated 2.7 million hours to various department programs. The Independent Sector, a national organization, establishes rates to determine the value of volunteer hours. Using these rates, we calculate the value of County volunteer service hours to be \$55.1 million dollars.

The 28<sup>th</sup> Annual Volunteer of the Year Recognition and Awards luncheon will be held on Monday, April 12, 2010, at 11:30 a.m., in the Grand Hall, Dorothy Chandler Pavilion of the Music Center. Once again, our master of ceremonies will be popular broadcast journalist Tony Cox, a native of Los Angeles, and the host of National Public Radio's "Upfront with Tony Cox."

On April 12, we will recognize 25 youth and 46 adult volunteers, whose dedicated service builds bridges between the County and our diverse communities. We expect more than 400 guests to attend, including department Heads and judges from Los Angeles Superior Court.
