SUBJECT: **CONTRACT RENEWAL OF DRIVING-UNDER-THE-INFLUENCE AGREEMENTS**

This is to inform you of the intent of the Department of Public Health (DPH) to request authority from the Board to renew Driving-Under-the-Influence (DUI) Program agreements for three years. The current agreements will expire on September 30, 2010. Renewal of these agreements will ensure that the provision of DUI program services continue without interruption. Attachment 1 is a list of the agreements by Supervisorial District.

**Background**

The objective of the DUI Program is to decrease the incidence of DUI offenses through developing awareness among DUI offenders of the impact, significance, and consequences of a DUI offense and assist in the rehabilitation of the offenders in decreasing or abstaining from alcohol use. The DUI program has different courses designed for first and multiple repeat offenders. First DUI offenders must attend the program for three months, second offenders for 18 months, and third and subsequent offenders for 30 months.

DUI offenders are required to pay a user fee to participate in the DUI programs. This fee, which is based on an ability to pay model, includes an administrative fee that is collected by the providers and is remitted to the County. The fee (\$24 for first offenders and \$49 for multiple offenders) is used to offset County administrative costs associated with the monitoring of all DUI Program providers.

**The DUI Program in Los Angeles County**

Although the State Department of Alcohol and Drug Programs (SDADP) licenses the providers to provide DUI Program services, counties assume much of the programmatic responsibilities. In Los Angeles County, the DPH Substance Abuse Prevention and Control (SAPC) administers the program. According to State guidelines, SAPC monitors DUI Program providers on a semi-annual basis.

Additionally, SAPC is required to review new applications for licensure as a DUI Program. Pursuant to State regulations, SAPC can only enter into contract with new providers if there is a demonstrated need (i.e., increased populations and/or convictions, the de-licensure of a program, or if there is a demographic that is not being served by the existing programs). Counties must also assure that the addition of a new DUI Program provider/s will not jeopardize the fiscal integrity of existing programs.

### **Recommendations**

DPH recommends the Board approve the renewal of the existing contracts with DUI programs for a three-year period, from October 1, 2010 through September 30, 2013. DPH does not recommend accepting any new provider applications at this time. This decision is based on enrollment rate data over the past ten years (see attached chart). According to the data, enrollments have been fairly consistent and provider use has not increased. Additionally, based on DPH's monitoring reports, all of the current providers have provided satisfactory services and are in good standing.

SAPC will continue to assess whether there is a need to increase the number of providers. If a demonstrated need for more DUI programs arises, SAPC will conduct a Request for Proposals (RFP) process to identify potential providers and return to the Board for approval. In the event there is no increase in need, DPH will return to the Board after the three-year period to request another extension.

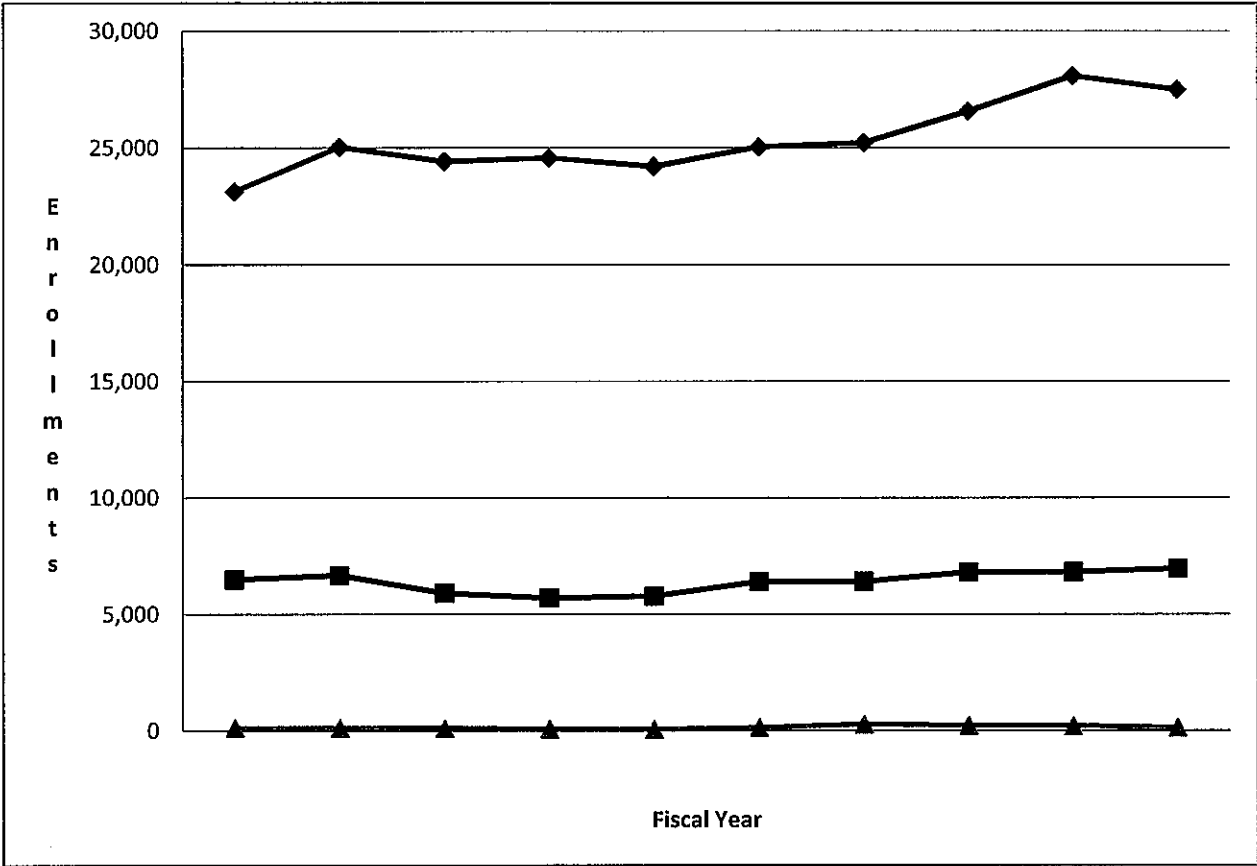
