SUBJECT: **FUNDING AUGMENTATION FOR SEPULVEDA REHABILITATION CENTER,
LLC, COUNTY CONTRACT NO. H-801674**

This is to inform you that the Department of Public Health (DPH) plans to use the delegated authority granted by the Board on May 31, 2005 (Board Agenda Synopsis #42) to amend the County's estimated maximum obligation and corresponding maximum allocation for the above subject agreement. The agreement provides flexibility to adjust funding allocations, and contains provisions that authorize the Director of DPH, or his designee, to make such funding changes.

DPH recommends this funding increase based on the Sobky v. Smoley court litigation which allows agencies to request additional funds to cover persons eligible for Drug/Medi-Cal services. Attachment 1 is a description of the services to be revised by this amendment and Attachment 2 outlines the agency's current and new proposed funding amounts.
