**NOTIFICATION OF AMENDMENT TO INCORPORATE AB 12 IN WRAPAROUND
APPROACH SERVICES CONTRACTS**

This is to notify your Board that the Chief Probation Officer, the Director of Mental Health, and I have used Board delegated authority to amend the Wraparound Approach Services (Wraparound Services) contracts with the 34 current contractors as adopted by your Board on April 28, 2009. The list of the 34 contractors is attached. Effective with the execution of these amendments, eligible youth will receive Wraparound Services up to age 21.

There is no fiscal impact, as the Board previously approved the Wraparound Tier II funding on April 28, 2009, in the amount of \$6,365.00; which was incorporated by Katie A. and is sufficient to provide Wraparound services in the existing contract for the estimated expanded youth population eligible for services under AB 12.
