SUBJECT: **NOTIFICATION OF THE USE OF DELEGATED AUTHORITY TO ACCEPT NOTICE OF AWARD NUMBER 1U62PS003680-01 REVISED FROM THE CENTERS FOR DISEASE CONTROL AND PREVENTION FOR THE COMPREHENSIVE HIV PREVENTION PROJECT**

This is to notify you that I am exercising the delegated authority approved by your Board on June 12, 2012, to accept future awards and/or amendments that are consistent with the requirements of Notice of Award (NA) Number 1U62PS003680-01 from the Centers for Disease Control and Prevention (CDC) that provide the balance of the base award for grant year 2012 and reflect non-material and/or ministerial revisions to the award's terms and conditions, subject to review and approval by County Counsel, and notification to your Board and the Chief Executive Office.

On June 12, 2012, your Board approved acceptance of: 1) NA Number 1U62PS003680-01, in the amount of \$7,495,775, which represented 50 percent of the anticipated \$14,991,550 total funding for HIV Prevention Core Funding (Category A) and Expanded HIV Testing (Category B) for the period of January 1, 2012 through December 31, 2012; and 2) NA Number 1U62PS003680-01 REVISED, in the amount of \$1,665,227, which represented 100 percent of the total funding for Demonstration Projects to Implement and Evaluate Innovative, High Impact HIV Prevention Interventions and Strategies (Category C) for the period of March 1, 2012 through December 31, 2012, for a combined award of \$9,161,002.

Under the delegated authority referenced above, I will accept NA Number 1U62PS003680-01 REVISED, issued June 19, 2012, to:

- 1) Award \$6,768,763, the remaining balance of the total award for the period of January 1, 2012 through December 31, 2012 consisting of \$5,544,175 for Category A and \$1,224,588 for Category B. This amount reflects a reduction of \$700,000 in anticipated Category A funds to be awarded directly to the City of Long Beach as well as a Congressional Rescission of 0.189 percent to Category A and B funds.
- 2) Accept the Department of Public Health's response to the Summary Statement and indicate that the corresponding award requirement has been met.

The revised award totals \$15,929,765 consisting of \$11,810,715 in Category A funds, \$2,453,823 in Category B funds, and \$1,665,227 in Category C funds. These funds support the implementation of comprehensive HIV prevention programs that focus on achieving maximum impact on reducing new HIV infections. The Comprehensive HIV Prevention Project replaces the previous CDC HIV/AIDS Prevention Cooperative Agreement and the Expanded HIV Testing for Disproportionately Affected Populations Grant and focuses on addressing the local HIV epidemic by: reducing infections, identifying new infections utilizing HIV surveillance, increasing access to care, enhancing linkages to care, improving health outcomes for people living with HIV, and promoting health equity.

DPH will request approval of an appropriation adjustment with the CEO's mid-year Budget Adjustment.

County Counsel has reviewed and approved NA Number 1U62PS003680-01 REVISED as to use and this delegated authority action.
