## **REQUEST FOR EXTENSION OF REPORT ON HAULED WATER STUDY (ITEM NO. 16, AGENDA OF SEPTEMBER 4, 2012 MOTION)**

On September 4, 2012, the Board, on motion of Supervisor Antonovich, instructed the Chief Executive Officer (CEO), in conjunction with the Hauled Water Task Force (Task Force) to: (1) identify funding and direct the Task Force to develop a work program, outreach plan, and estimated timeline for the issuance of a Request for Proposal for purposes of retaining a consultant to prepare an initial study, and, if necessary, an Environmental Impact Report on the draft single family residential hauled water policy, as that policy is set forth in the CEO's August 17, 2012 report, which is in compliance with the California Environmental Quality Act (CEQA) guidelines; and (2) direct County Counsel, in consultation with the Task Force, to draft a proposed ordinance for the Board's consideration that amends applicable Los Angeles County Codes to provide for a single family residential hauled water use policy, which incorporates the provisions previously outlined, and in the Response to Public Comments document, subject to any amendments made by the Board, and as informed by the required CEQA analysis. This is to provide the Board with a status report on this issue.

The Task Force met on September 26, 2012, to discuss the items identified in the Board's motion, as it relates to the development of a work plan and scope for an initial study on the use of hauled water within select areas of the County. A follow-up meeting will be held within the next several weeks.
