SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 38 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of nine new Agreements processed in the month of October 2012, as follows:

1. **Amendment No. 4 (MH010089) with The Regents of the University of California, Los Angeles (UCLA)** reduces the Child System and Treatment Enhancement Projects, related to Addendum A, Subsection A2.6, Additional Academic and Medical Teaching Services for Recovery-Oriented Education and Training, in the amount of \$39,000.
2. **Amendment No. 5 (MH010089) with The Regents of the University of California, Los Angeles (UCLA)** adds \$200,000 for the Transitional Research Program Projects, related to Addendum A, Subsection A2.4, Additional Academic and Medical Teaching Services, Program Evaluation and Research Focusing on Improving Services for Underserved Populations and Geographic Areas with Substantial Component in Conjunction with Agencies such as the National Institute of Mental Health.
3. **Amendment No. 4 (MH050042) with Mental Health America of Los Angeles** increases the Service Extenders Program funds in the amount of \$123,000 for Fiscal Year (FY) 2012-13, with a revised Total Contract Amount of \$653,800.
4. **Amendment No. 1A (MH120874) with Ocean Park Community Center** shifts \$12,000 of Homeless Non Medi-Cal direct/indirect services funding to Homeless Non Medi-Cal Manual invoice funding with no change to the Maximum Contract Amount (MCA).

5. **Amendment No. 1 (MH120917) with McKinley Children's Center, Inc.**, deletes Mode 10, Service Function Codes (SFCs) 95-99, Day Rehabilitation Services – Full Day, from Provider Number (PN) 7436, located at 762 W. Cypress Street, San Dimas, CA 91773.
6. **Amendment No. 3 (MH120926) with South Central Health and Rehabilitation Program** decreases MHSA Innovations (INN) Programs (Non Medi-Cal/Non Healthy Families (HF)) funds in the amount of \$54,000. The funds will be transferred to JWCH Institute, Inc., a Department of Mental Health Contractor, who is a participant to the MHSA INN Program. The revised MCA for FY 2012-13 is \$10,062,399.
7. **Amendment No. 1 (MH120929) with The Children's Center of the Antelope Valley** adds Mode 45 (Outreach Services), SFC 10 (Mental Health Promotion), and SFC 20 (Community Client), at a provisional rate of \$68.00 to PN 748. There is no change to the MCA.
8. **Amendment No. 1 (MH120940) with Bayfront Youth & Family Services** adds \$623,937 for the FYs 2012-13 and 2013-14 for the provision of Day Treatment Intensive and Medication Support for Bayfront Group Home. The Amendment also adds the service delivery site located at 4151 Fountain Street, Long Beach, CA 90804. The PN is To Be Determined (TBD).
9. **Agreement (MH150295) with Suburban Drug dba Los Coyotes Drug** is being executed under the Pharmacy Agreement. The term of the Agreement is from October 25, 2012, through June 30, 2015.
10. **Agreement (MH200378) with Families for Children, Inc.**, is being executed under the MHSA Master Agreement. The term of the Agreement is from October 18, 2012, through June 30, 2016.
11. **Agreement (MH210037) with Korean Health, Education, Information and Research Center** is being executed under the 1115 Waiver Demonstration Project Community Partner Agreement. The term of the Agreement is from October 1, 2012, through December 31, 2014.

There is no change in the MCA.

18. Amendment No. 4 (MH150281) with Pai and Chan Pharmacy Corp., II, dba Key Drug Co. Assignor Skuro Drug Co. dba Key Drug Co., to Assignee, Pai and Chan Pharmacy Corp., II, dba Key Drug Co. There is no change to the MCA.

The following four Amendments (19 through 22) to Specialized Agreements decrease/increase MHSA PEI Non Medi-Cal/Non HF and/or MHSA PEI Medi-Cal/HF funding program funds:

The revised MCA will be \$1,637,503 for FY 2012-13 only.

20. Amendment No. 4 (MH050038) with California Mental Health Directors Association increases MHSA PEI funds in the amount of \$53,143. The revised MCA will be \$389,143 for FY 2012-13 only.

21. **Amendment No. 4 (MH050039) with California Institute for Mental Health** increases MHSA PEI funds in the amount of \$10,000 and adds Department of Public Health Substance Abuse Prevention and Control funds in the amount of \$10,000. The revised MCA will be \$534,875 for FY 2012-13 only.
22. **Amendment No. 5 (MH210004) with Central City Community Health Center, Inc.**, increases MHSA PEI funds for Specialty Mental Health Services in the amount of \$50,975. The revised Estimated Maximum Amount will be \$93,251.
