SECOND INSTALLMENT PERIOD**

We are taking this opportunity to advise you of the upcoming deadline for the second installment of the 2012-2013 secured property taxes.

The attached press release alerts taxpayers that the second installment becomes delinquent if not paid by 5:00 p.m., Wednesday, April 10<sup>th</sup>. Mailed payments must be postmarked by the United States Postal Service no later than April 10, 2013.

The attached press release will be mailed to approximately 250 newspaper companies, television and radio stations. We will also email the press release to all constituents who have enrolled in our *Email Notification Service*.

As a result of these efforts, you may experience an increase in constituent inquiries or visits to your offices. Any inquiries received regarding the payment of taxes may either be referred directly to the first floor, Public Service Counter, in the Kenneth Hahn Hall of Administration or to our property tax automated telephone system (Proptax) at 1(213) 974-2111 or the toll-free number at 1(888) 807-2111.

### **FOR IMMEDIATE RELEASE**

**MARK J. SALADINO**, Los Angeles County Treasurer and Tax Collector, reminds property owners that the second installment of the 2012-2013 property taxes becomes delinquent if not received by 5:00 p.m. or United States Postal Service (USPS) postmarked no later than April 10, 2013. "To avoid late penalties, taxpayers should not wait until the statutory deadline; please pay early" says Treasurer and Tax Collector Saladino.

Taxpayers who send their payment by mail are cautioned that the USPS or independent delivery service often does not postmark envelopes on the day they are deposited in the mail. If mailing on or near the April 10<sup>th</sup> delinquency date, be sure to obtain a hand cancellation or Certificate of Mailing. Only official USPS postmarks are acceptable as proof of mailing; the date shown by a postage meter or electronic postage is not legally acceptable as proof of mailing.

To ensure proper processing of payments, make checks payable to the Los Angeles County Tax Collector and include the appropriate second installment payment stub marked "2". Substitute Secured Property Tax bills can be obtained from the Treasurer and Tax Collector's Office or any local Assessor's Office.

The amount due on any parcel can also be obtained from the Treasurer and Tax Collector's website at <http://ttc.lacounty.gov>, or call the toll free Property Tax Information Line at 1(888) 807-2111, where automated information is available 24 hours a day.

Taxpayers can pay online by going to the Treasurer and Tax Collector's website at <http://ttc.lacounty.gov>, or to the property tax web portal at <http://lacountypropertytax.com> and select "Make Online Payment." To make an online payment, you will need a checking account for an electronic payment (eCheck) and a Personal Identification Number (PIN) that is printed on the original bill. There is no fee to pay by eCheck.

Additionally, credit cards (American Express, Master Card, and Visa) and Visa Debit card payments are accepted online and over the telephone by a third-party vendor who charges a fee to utilize this service. Call toll free at 1(888) 473-0835. You will need your current year tax bill and credit or debit card to complete the transaction. Please retain the confirmation number for future reference. Each transaction is limited to \$24,999.99.

When property owners have completed their online payment transaction, a confirmation number will be provided as verification of payment, which can be printed for their records.

No cash payments can be accepted at this location.
