2012 VOLUNTEER HOURS AND 2013 AWARDS LUNCHEON ON APRIL 15, 2013

The County of Los Angeles benefited from the efforts of 51,000 volunteers last year, who donated 2.7 million hours to various department programs. The Independent Sector, a national organization, establishes rates to determine the value of volunteer hours. Using these rates, we calculated the value of County volunteer service hours to be \$57 million dollars.

This year we will honor 25 youth and 56 adults at the 31st Annual Volunteer of the Year Awards and luncheon on Monday, April 15, 2013, at 11:30 a.m., in the Grand Hall, Dorothy Chandler Pavilion of the Music Center. We expect more than 475 guests to attend, including department heads and judges from Los Angeles Superior Court.

Our host will be Jessica Carrillo, entertainment host of "Acceso Total" for Los Angeles' NBC-Telemundo. Jessica brings viewers the entertainment world reports, the latest information about celebrity newsmakers, and exclusive interviews. Her show also runs in nine other major markets.
