NOTIFICATION TO EXECUTE THREE TRANSITIONAL HOUSING PLACEMENT PROGRAM CONTRACTS AND TO EXTEND TRANSITIONAL HOUSING PROGRAM-PLUS SERVICES CONTRACTS

This is to notify the Board that I have used Board delegated authority to execute three new Transitional Housing Placement Program (THPP) contracts, and in conjunction with the Chief Probation Officer, we have jointly executed 12 amendments for Transitional Housing Program-Plus (THP-Plus) contracts. As adopted by the Board on June 4, 2013, the amendments will extend the current 12 THP-Plus contracts for one year effective July 1, 2013, through June 30, 2014, to complete the Request for Proposal (RFP) process. The new contracts will extend the current three THPP contracts effective July 1, 2013, through June 30, 2014, with an option to extend for an additional six months from July 1, 2014, through December 31, 2014, to complete the solicitation to incorporate Assembly Bill (AB) 12 for the provision of the combined THPP/Transitional Housing Placement Plus Foster Care services.

The estimated maximum cost of the extension for the THP-Plus contracts is \$2,165,106, financed using 100 percent State revenue. The estimated maximum cost of the one-year extension for THPP contracts is \$1,661,760, financed using 36 percent (\$598,234) Federal revenue, 33 percent (\$548,381) State revenue and 31 percent (\$515,145) net County cost.

The THPP and THP-Plus contracts assist youth in transitioning from dependence to economic self-sufficiency as adults through supervised transitional living/housing and other needed support services.
