NOTIFICATION TO AMEND GROUP HOME FOSTER CARE SERVICES CONTRACTS NUMBER 07-023-011 WITH CHILDREN'S HOMES OF SOUTHERN CALIFORNIA, NUMBER 07-023-021 WITH DREAM HOME CARE, INC. AND NUMBER 07-023-061 WITH PENNACLE FOUNDATION, INC.

This is to notify the Board that the Chief Probation Officer and I have used Board-delegated authority to amend Group Home (GH) Foster Care Services Contracts Number 07-023-011 with Children's Homes of Southern California, Number 07-023-021 with Dream Home Care, Inc. and Number 07-023-061 with Pennacle Foundation, Inc. to increase their contracted capacity by six beds and add an emergency shelter care services component to provide 24-hour intake emergency shelter care services as provided in the Board letter adopted by the Board on September 18, 2012.

The estimated placement cost for Children's Homes of Southern California's GH contract amendment is \$615,624, financed with 36 percent (\$221,625) Federal revenue, 33 percent (\$203,156) State revenue, and 31 percent (\$190,843) net County cost; the estimated placement cost for Dream Home Care, Inc.'s GH contract amendment is \$574,584, financed with 36 percent (\$206,850) Federal revenue, 33 percent (\$189,613) State revenue, and 31 percent (\$178,121) net County cost and the estimated placement cost for Pennacle Foundation, Inc.'s GH contract amendment is \$615,624, financed with 36 percent (\$221,625) Federal revenue, 33 percent (\$203,156) State revenue, and 31 percent (\$190,843) net County cost.
