**DEPARTMENT OF CHILDREN AND FAMILY SERVICES' REQUEST TO APPOINT  
MS. DIANA IGLESIAS TO THE POSITION OF SENIOR DEPUTY DIRECTOR,  
CHILDREN AND FAMILY SERVICES (UNCLASSIFIED)**

Consistent with Board-approved Policy on management appointments, the Department of Children and Family Services, with the support of the Chief Executive Office, requests approval to appoint Ms. Diana Iglesias to the position of Senior Deputy Director, Children and Family Services (UC), at an annual base salary of \$165,000. This salary is recommended based on Ms. Iglesias' education, which includes a law degree, her extensive experience and the role and responsibilities she will be assuming in this critical position.

As Senior Deputy Director, Children and Family Services, Ms. Iglesias will report to the Director and will serve as a key member of the Department's Executive Team. She will act as Departmental liaison to the Office of the County Counsel, CEO-Risk Management, the Children's Special Investigation Unit (CSIU), and to your Board on issues of sensitive cases, critical incidents and child fatalities. Ms. Iglesias will also be given direct management and supervision of the Government Accountability and Risk Management Division which oversees child fatality assessments, litigation, investigations, and a number of other areas.

In her current position of Assistant Lead Attorney, CSIU, Ms. Iglesias conducts independent legal review of child deaths and other serious incidents involving children under the care and/or supervision of County departments in order to identify systemic issues. She has been active in developing countywide changes designed to prevent child injuries or deaths.

Unless otherwise instructed by your Board by January 30, 2014, the Chief Executive Office will advise the Department of Children and Family Services that authorization has been granted to proceed with Ms. Iglesias' appointment to Senior Deputy Director, Children and Family Services (UC), at an annual base salary of \$165,000, effective no sooner than January 31, 2014.
