**NOTIFICATION OF AMENDMENTS TO FOSTER FAMILY AGENCY (FFA) AND GROUP HOME (GH), AND RENEWALS OF THE FFA-EMERGENCY SHELTER CARE (ESC) CONTRACTS**

This is to notify the Board that the Chief Probation Officer and I have exercised Board delegated authority to execute amendments to 46 FFA contracts (listed in Attachment A) and 70 GH contracts (listed in Attachment B) to incorporate Overpayment Regulations promulgated by the California Senate, other changes and updates, and to extend the term of these contracts effective May 1, 2014, through April 30, 2015.

The estimated annual maximum sum of the FFA contracts (including the companion FFA-ESC contracts) is \$126,200,000 and the estimated maximum sum of the GH contracts is \$200,000,000; for a total estimated FFA and GH annual placement cost of \$326.2 million.
