**BOARD MOTION OF DECEMBER 8, 2009, AGENDA ITEM 25
COSTS ASSOCIATED WITH THE LOCAL WORKER
JOB ORDER CONTRACT PROGRAM
FOURTH QUARTER 2014**

This is in response to the Board's December 8, 2009, motion directing Public Works to report quarterly on the costs associated with the Local Worker Job Order Contract Program (see attached).

From December 22, 2009, through November 15, 2014, Public Works executed 112 Job Order Contracts with a total value of \$458.1 million. The cost for setting up the Local Worker Program was \$58,843 and an additional \$932,664 for tracking the hiring of local workers from 2009 through this reporting period.

During this reporting period, Public Works utilized the Job Order Contracts to issue 108 work orders totaling \$5,942,425.62. Public Works staff expended 505 hours, at a cost of \$68,910, to manage the Local Worker Program for these work orders. The table on the next page summarizes Public Works' costs for the last four quarters, including local worker participation rate associated with the Local Worker Program.
