SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 53 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal (MC) Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs, and execution of seven new Agreements processed in the month of September 2014 as follows:

1. **Amendment No. 2 (MH050109) with University of California, San Diego** extends the term of the Agreement for an additional 18 months effective January 1, 2015, through June 30, 2016. The Total Compensation Amount (TCA) will be \$1,142,857 for Fiscal Year (FY) 2014-15 and \$390,000 for FY 2015-16.
2. **Amendment No. 5 (MH120915) with Los Angeles Unified School District (LAUSD)** extends the Agreement for a period of three years, beginning July 1, 2013, through June 30, 2016.
3. **Amendment No. 3 (MH121150) with San Fernando Valley Community Mental Health Center, Inc.**, adds Diversion Program Non MC/Non Healthy Families (HF) funds in the amount of \$110,138; Diversion Program MC/HF funds in the amount of \$218,210; and Diversion Program Invoice funds in the amount of \$113,037 for FYs 2014-15, 2015-16, and 2016-17. The revised Maximum Contract Amounts (MCAs) are \$441,385, \$441,385, and \$441,385, respectively.
4. **Amendment No. 1 (MH121177) with ASC Treatment Group dba The Anne Sippi Clinic** adds Support Services Client Supportive Services, Mode 60, Services Function Codes (SFCs) 64/70-78 to Service Delivery Site under existing MC/Short-Doyle Provider Number (PN) 7589. There is no change to the MCA.
5. **Amendment No. 2 (MH121178) with Bienvenidos Children's Center** increases First 5 LA funds for the Parent Child Interaction Therapy services MC

funds in the amount of \$84,000, increases First 5 LA Non MC/Non HF funds in the amount of \$17,000, and increases First 5 LA Invoice funds in the amount of \$15,000 for FY 2014-15 only. The revised MCA is \$5,274,718.

6. **Agreement (MH190122) with Mental Health Advocacy Services, Inc.**, was executed under the MC Outreach and Enrollment Agreement. The term of the Agreement is from July 1, 2014, through June 30, 2016.
7. **Agreement (MH190123) with MHSAs Housing Program Assignment Agreement** the term of the Agreement is from July 1, 2014, through June 30, 2015.

The following five Agreements (8 through 12) were executed under the MHSAs Agreement funds:

8. **Agreement (MH200428) with Young Women's Christian Association (YWCA) of Greater Los Angeles** the term of the Agreement is from September 23, 2014, through June 30, 2016.
9. **Agreement (MH200429) with Ascencia** the term of the Agreement is from September 2, 2014, through June 30, 2016.
10. **Agreement (MH200430) with Homeboy Industries** the term of the Agreement is from September 3, 2014, through June 30, 2016.
11. **Agreement (MH200431) with Ella's Foundation** the term of the Agreement is from September 2, 2014, through June 30, 2016.
12. **Agreement (MH200432) with Special Spirit, Inc.** the term of the Agreement is from September 29, 2014, through June 30, 2016.
