SUBJECT: **NOTIFICATION OF THE USE OF DELEGATED AUTHORITY TO
ACCEPT TWO NOTICES OF AWARD FROM THE CENTERS FOR
DISEASE CONTROL AND PREVENTION FOR THE COMPREHENSIVE
HIV PREVENTION PROJECT**

This is to notify you that I am exercising the delegated authority approved by your Board on June 12, 2012, to accept future awards and/or amendments that are consistent with the requirements of the Centers for Disease Control and Prevention's (CDC) Comprehensive HIV Prevention Project for Health Departments (CHPP) Notice of Award (NA) Number 1U62PS003680-01 that: 1) extend the term through December 31, 2017; and 2) reflect non-material and/or ministerial revisions to the award's terms and conditions, subject to review and approval by County Counsel, and notification to your Board and the Chief Executive Office.

On February 3, 2015, I notified your Board that I was exercising delegated authority to accept CDC NA Number 5U62PS003680-04, in the amount of \$3,113,240. The award represented 20 percent of anticipated funding for calendar year (CY) 2015.

Under the delegated authority referenced above, I will accept:

- 1) CDC NA Number 5U62PS003680-04 REVISED, Amendment 1, issued on February 18, 2015, in the amount of \$7,783,102. The award is comprised of \$5,813,969 for HIV Prevention Core Funding-Category A; \$1,173,063 for Expanded Testing for Disproportionate Populations-Category B; and \$796,070 for Demonstration Projects to Implement and Evaluate Innovative, High Impact HIV Prevention Interventions and Strategies-Category C. The award represents 50 percent of the approved funding of \$15,566,202 for CY 2015. The total award amount received to date is \$10,896,342.

The remaining award in the amount of \$4,669,860 is subject to availability of funds and satisfactory progress of the project. This NA also approves the revised budget submitted to the CDC on January 31, 2015.

- 2) CDC NA Number 5U62PS003680-04 REVISED, Amendment 2, issued on February 20, 2015, to correct the approved revised budget total as reflected in Section III of the Terms and Conditions, of NA 5U62PS003680-04 REVISED, issued on February 18, 2015, from \$15,566,602 to \$15,566,202 for CY 2015. All other terms and conditions remain in effect.

Acceptance of these NAs will allow DPH to continue to address the local HIV epidemic by reducing infections, identifying new infections utilizing HIV surveillance, increasing access to care, enhancing linkages to care, improving health outcomes for people living with HIV, and promoting health equity.

County Counsel has reviewed and approved the NAs as to use and this delegated authority action.
