LIVING WAGE PROGRAM
ANNUAL REPORT
January 1, 2015 – December 31, 2015

I. Introduction

The Board of Supervisors adopted the County's Living Wage Program (LWP) on June 15, 1999 (Los Angeles County Code, Title 2, Chapter 2.201). The Countywide Contract Compliance Section of the Internal Services Department (ISD) is responsible for monitoring compliance with the LWP.

Departments are responsible for conducting day-to-day monitoring efforts of their respective contracts subject to the LWP. ISD's LWP responsibilities include:

- Providing an annual report on department and contractor compliance with the LWP.
- Providing guidance and information to departments concerning their LWP responsibilities.
- Assisting departments and providing centralized monitoring of LWP contracts and requirements.

The LWP applies to Proposition A contracts and cafeteria services contracts commencing on or after October 22, 1999. This LWP Annual Report covers a calendar year reporting period from January 1 through December 31, 2015.

This report encompasses 15 departments and 195 LWP contracts. The report summarizes department and contractor compliance and data on salary and healthcare benefits, including the following exhibits:

Exhibit A - 2015 Department Contract Summary

Identifies the department acronyms used in the exhibits and a summary of the number of contracts per department.

Exhibit B - Proposition A - Cafeteria Services Contracts

Identifies active LWP contracts as of December 31, 2015.

Exhibit C - 2015 Sub-Contractor Report

Provides a list of current sub-contractors servicing LWP contracts.



II. Living Wage Program Accomplishments

ISD continues to ensure that departments and contractors understand their roles and responsibilities under the LWP, and provides guidance on policy changes to ensure compliance. During this period, ISD completed the following:

- Provided technical assistance to departmental staff to improve their understanding, monitoring activities, and ensured that contract solicitations complied with LWP requirements.
- Conducted three training sessions, with a total of 108 County employees, regarding the implementation of the revised LWO.
- Conducted four training session, with a total of 110 County employees, regarding LWP solicitations and monitoring procedures.
- Participated in 19 Proposers Conferences and 21 Pre-Job Conferences to provide contractors with program information to ensure their understanding of the LWP.
- Conducted reviews of County departments to ensure compliance with monitoring Proposition A and cafeteria services contracts consisting of various services (see **Figure 1**). ISD efforts included reviewing departmental living wage contracts, managing the LWP hotline, and responding to inquiries/complaints from departments, contractors and contract workers, as well as reporting instances of non-compliance issues to respective departments for corrective action and follow-up.

III. Monitoring

a) Departmental Compliance Reviews

ISD reviewed 54 LWP contracts across 15 departments to evaluate completeness, accuracy, timeliness of monitoring responsibilities and departmental maintenance of documentation as required by the LWP. The compliance reviews revealed general compliance by the departments and contractors in monitoring their LWP contracts.

Overall, compliance reviews indicated that most departments have adhered to Board instructions by using the standardized monitoring forms, conducting annual on-site administrative reviews with contractors, following guidelines and generally complying with the Living Wage Ordinance (LWO) requirements and relevant State and federal labor laws.

b) Employee Interviews

ISD reviewed contract worker questionnaires for each department to ensure employee interviews were conducted within the guidelines established for the LWP. Employees were asked to verify contractor compliance in accordance with the LWP's Notice to Employees. ISD confirmed, when applicable, that departments verified the LWO posters were displayed in conspicuous areas. ISD also verified that employees were working full-time and paid in accordance with the applicable LWO rates.


In addition, ISD verified that employee wages and health care benefits, if any, were accurately reflected in the contractors' payroll reports and if applicable, that employees received health care benefits. No significant discrepancies were found between employee statements contained in the questionnaires and contractors' reported wages and health benefits. Where these reviews identified isolated instances of possible contractor violations (e.g., labor law, contract performance terms, etc.), ISD notified respective departments of findings and followed up to ensure the issue(s) were addressed and resolved. LWP guidelines require departments to interview at least 10% of the contract employees or, if the contractor employs 10 employees or fewer, the department must interview all employees. ISD found that departments were compliant with conducting the required number of interviews.

c) Employers Offering Healthcare Benefits

Under the current LWP, all employers must pay their employees either: (1) a living wage of \$11.84 per hour without healthcare benefits, or (2) \$9.64 per hour plus no less than \$2.20 per hour per employee toward healthcare benefits. These pay rates apply to all applicable Living Wage contracts.

Based on data gathered from departments, employers offering health benefits (see **Figure 2**) are as follows:

Figure 2 - Health Benefits Data



- 53% - 104 contracts pay \$11.84 per hour without health benefits
- 28% - 55 contracts pay \$11.84 per hour and provide some form of health benefits (less than \$2.20 per hour)
- 5% - 9 contracts pay \$9.64 and contribute at least \$2.20 per hour toward health benefits
- 14% - 27 contracts are exempt (23 contributed to health benefits; 4 did not contribute to health benefits)

IV. Technical Assistance and Training Activities

Technical Assistance

ISD continued to provide technical assistance and training to departmental contract staff regarding their responsibilities to enforce LWP requirements. ISD provided direction to County departments for clarifying and resolving LWP labor/payroll issues. ISD also provided technical assistance to departments during their solicitation process by reviewing contract information (e.g., solicitation documents, staffing plans, forms, exemption requests, and evaluation criteria) to ensure that departments met all LWP criteria. During this reporting period, there were 73 documented instances of technical assistance provided to departments.

Training

ISD continued to provide training and guidance to department staff responsible for administering and monitoring LWP contracts. ISD conducted three, four-hour training classes as part of the Auditor-Controller's (A-C) 32-Hour Contract Monitoring Certification Program. Classes were conducted on February 19, May 20, and October 15, 2015. A total of 87 employees were trained.

In addition, ISD conducted a four-hour Living Wage Ordinance Compliance Monitoring Training on April 20, 2015. A total of 23 employees were trained.

V. Evaluation of Labor Law/Payroll Violations

The County's Labor Law/Payroll Violations Assessment Team (Assessment Team) reviews and assesses the severity and extent of labor violations of firms submitting proposals to provide services under LWP contracts. The Assessment Team

consists of representatives from ISD, Department of Public Works (DPW), and the Chief Executive Office (CEO) with County Counsel serving as the legal advisor.

Based on the severity, number, and completeness of disclosure, of reported claims and/or violations, the Assessment Team recommends deductions to evaluation scores consistent with the Guidelines for Assessment of Proposer Labor Law/Payroll Violations.

During this reporting period, the Assessment Team evaluated eight proposers with reported claims for and/or labor law/payroll violations. The following summarizes the Assessment Team's recommendations:

- Six proposers were classified as having no violations, and received recommendations for no deductions to their evaluation score.
- Two proposers were classified as having insignificant violations, some of which were not fully disclosed, and received a recommended deduction of one percent (1%) on their evaluation score.

VI. Living Wage Program Objectives Update

The report includes the following:

- The total number and costs of LWO contracts.
- Updated information regarding annual living wage rate increases.

The following subsections provide updates since our last report.

a) Automated Tracking of Contract Costs

The methodology utilized to determine the costs of LWO contracts includes obtaining information from the ISD database of active LWP contracts which the Auditor-Controller reconciles with eCAPS to validate contract costs. The results are presented in **Table 1**.

b) Revision of Living Wage Rates

The data presented in this report is based on the current LWO.

In July 2015, the Board noted that the LWO has not kept pace with changes in the economy and did not reflect the basic cost of living without dependence on government benefits. In addition, the Board found that due to the implementation of the Affordable Care Act and other legislative changes, the LWO framework and methodology should be restructured to reflect current realities including current housing and consumer costs.

As a result, on December 8, 2015, the Board approved revisions to the LWO which will affect, among other things, the living wage rates. Below is a brief discussion on the changes to the LWO which will become effective March 1, 2016.

1. Eliminates the Two-Tier Wage Structure

The amended LWO eliminates the two-tier living wage structure and implements a single tier system. As a result, contractors will be required to pay employees subject to the LWO, one hourly rate, regardless of whether medical insurance is provided or not.

2. Identified Adjustments to the Living Wage Rates

The amended LWO identifies annual adjustments to the living wage rates. The following table lists the hourly living wage rates with the corresponding effective dates.

Annual Adjustments to the Living Wage Rates

Effective Date	Hourly Rate
March 1, 2016	\$13.25
January 1, 2017	\$14.25
January 1, 2018	\$15.00
January 1, 2019	\$15.79
January 1, 2020 and beyond	See below

Effective January 1, 2020, the living wage rate will be adjusted based on the U.S. Department of Labor, Bureau of Labor Statistics' Consumer Price Index (CPI) for the Los Angeles-Riverside-Orange County Area for the 12-month period preceding July 1 of each year.

The Chief Executive Office (CEO) will issue a memo in August 2019 advising departments of the CPI to be used when determining the living wage rate effective January 1, 2020, and every year thereafter.

3. Expanded the LWO to include Part-Time Employees

The amended LWO requires contractors to pay all employees working on the County's living wage contracts and subcontracts the living wage rate regardless of the number of hours worked or part-time/full-time status.

4. Required Non-Exempt Contractors and Subcontractors to pay the Living Wage Rate or County's Minimum Wage

The amended LWO requires non-exempt contractors and subcontracts to pay employees working on the County's living wage contracts and subcontracts at least the living wage rate or the County's minimum wage, as defined in Title 8 (Consumer Protection, Business and Wage Regulations) commencing with Section 8.100.010 of the County Code, whichever is higher.

5. Eliminates the LWO exemption for small businesses and non-profits

The amended LWO eliminates the exemption for small businesses and non-profit organization. As a result, small businesses and non-profit organizations will be required to comply with all of the LWO requirements, including paying employees the revised hourly rates.

VII. Living Wage Hotline Calls

The Los Angeles County Living Wage Hotline is designed to receive calls reporting suspected LWP violations 24 hours per day, 7 days per week. During this reporting period, a total of 21 calls were received; eleven calls were related to the LWP and 10 were not. See **Table 2** below.

VIII. Conclusion

The following summarizes the current LWP status:

- Departments and contractors are generally compliant with the LWP.
- Departmental deficiencies were identified as follows and were referred to the appropriate departments for corrective action and follow-up:
 - Monitoring procedures.
 - Non-compliance with the LWP Implementation Instructions.

ISD will:

- Continue to monitor and provide technical assistance to departments and contractors.
- Address recurring problem areas in future LWP training sessions.
- Continue to oversee the LWP solicitation process and collaborate with the LWP Implementation Team (CEO, A-C, DPW, ISD, and County Counsel) to assist and interpret the LWP Implementation Instructions and address any new developments or issues to ensure countywide compliance.
- Conduct a semi-annual survey of all Proposition A and cafeteria contracts to collect cost and workforce data for all County departments and submit the results, in writing, to the Board.
