	Chair Johnson took this item out of order to accommodate the Sheriff's schedule, as he had to	
	attend a court hearing. Participating in the Commission meeting remotely, Sheriff Luna	
	provided the below report:	
	• Sheriff Luna said the Attorney General (AG)'s lawsuit alleging inhumane conditions in LA	
	County Jails "relies on outdated information and does not reflect the reforms and	
	compliance already in place."	

	 When reporting on immigration, the Sheriff noted that the LASD "stays away from (immigration enforcement), as much as we can" and urged crime victims/witnesses not to be afraid to come forward to the LASD. He said the LASD is "in complete connection" with local, state, and federal agencies to 	
	 He said the LASD is "in complete connection" with local, state, and federal agencies to "keep tabs" on potential political violence, esp. against LGBT communities. In response to concerns raised by the OIG, the LASD has developed crime scene entry 	
	protocols that would "ensure alignment with oversight expectations."

	Co-Vice Chair Garcia requested that LASD provide an update on health and behavioral	
	healthcare in the jails. The Sheriff did not immediately provide a response.	
	Saying LASD personnel are "not immune" to the current "climate of racial profiling," Chair Johnson usged them to speak out about the impact of federal immigration enforcement on	
	Johnson urged them to speak out about the impact of federal immigration enforcement on their own families and communities.	
	 Sheriff Luna said he "accepts that challenge," adding that many LASD employees come from 	
	immigrant backgrounds, including himself.

	 The Commission's Use of Force Ad Hoc was dissolved before it could make 	
	recommendations because LASD denied its information requests, citing confidentiality.

	PPOA Board President Lt. Stephen Johnson told the Commission: "We recognize oversight as a	
	necessity, but we insist that it operate within the boundaries of the law, fairness, and the	
	collective bargaining process." Lt. Johnson added that "oversight dysfunction risks	
	undermining both officer morale and public trust," and he urged the Commission to "consult with [PPOA], and not to bypass [PPOA] when creating policies that affect [PPOA] members."

	Commissioner Calloway asked if PPOA ever directed its members to respond to requests for	
	information from the Commission when the Commission followed due process in making	
	those requests. Lt. Johnson responded that because of three potentially related unfair labor practices cases being litigated by PPOA, he can only say that when PPOA's members are	
	subpoenaed, PPOA will fight for their procedural rights and due process.

	 Commissioner Giggans reminded Lt. Johnson that, during the first four years of the Commission, LASD "rejected oversight at every turn." She welcomes collaboration with PPOA. She acknowledged that "nobody wants somebody looking over their shoulder," but said the Commission has brought to light many community concerns that had been ignored. Commissioner Harris said if the LASD provided confidential information to the Commission, subpoenas would not have been issued. PPOA is a party to a lawsuit over the subpoenas. PUBLIC COMMENT Isaac Ashbury commented on deputy gangs Marisela Roses, Vanessa Perez, Yousef Miller, Julie Martinez, Anthony Arenas, Deanna Brock, Cindy Nunez and Pamela Serna each criticized Lt. Johnson's presentation, with some calling it "condescending," "insulting," and a "disgrace." They urged the Commission to 	1:41:52

He called the memo the "most caustic, corrosive, and chilling effort to squash the voice" of the Commission, OIG and Sybil Brand Commission (SBC).
