Steven Jimenez, Treasurer Tax, reported that this application is for an additional permit to allow live entertainment as a new business activity and that a public hearing is required. He also reported that the Sheriff's Department has no record of any violations, that there are no community complaints and that the applicant is in compliance.

The applicant, Lynn G. Martinez, explained that the establishment has coin operated games, dancing, one billiard table and a music disc jockey. She explained that she is applying for a permit to allow her to have a live band, a dressing room is not needed for the performers and that she is in a commercial area. She further explained on the hours and evenings of operation and that the stage is 18" high.
