#### **CHAIRMAN'S REPORT**

Chairman Svonkin reported on correspondence from Blue Cross. He reported that Blue Cross is asking for clarification to his questions and proposals, and that they will respond as to whether they will join the Commission with legislation on these issues. He also reported on an article from the Los Angeles Times wherein the Department of Managed Care stated that a policy will be forthcoming to prevent cancellations of coverage without good cause.

The Commission agreed to the following:

- Contact the Department of Managed Care as it relates to their policy to prevent cancellations of Medical and Health Care coverage
- Send congratulatory letters to the new Insurance Commissioner and new Legislators

Commissioner Callagy commented on a Los Angeles Times article wherein Blue Cross settled on pending litigation, and coincidently subsequent to the Commission's last meeting.

Chairman Svonkin noted the December 8, 2006 meeting to honor Governor Elect Garamendi for his accomplishments and contributions.

# **STAFF REPORT**

Gabriel Alexander reported on the Sunset Review. It was approved by the Audit Committee at their September 21, 2006 meeting and a Board letter is waiting for County Counsel to complete drafting of the ordinance.

Sandra Barbee reported on the Commission's website, it is up and running and the address is lacic.org. with all links working. There was discussion on potentially having the website name change. She also reported that a press release will be sent to announce the Commission's website.

# HONORING SENATOR ESCUTIA FOR DISTINGUISHED PUBLIC SERVICE; CHAMPION CONTRIBUTIONS IN PROTECTING HEALTH & ENVIRONMENT; IMPROVING EDUCATION & DEFENDING CONSUMER AND WORKER RIGHTS

Vice Chairman Falcon welcomed Marisela Cervantes, present on behalf of Senator Escutia.

Commissioner Brown suggested that a letter of condolences be sent to Assemblymemeber Karen Bass. He also suggested creating a committee to work with Rocky Armfield, Manager, LAC Risk Management in bringing together public private entities to participate with pooling monies for terrorism and earthquake coverage.
