4. Hearing on application for Entertainment - General / SC, Business License ID# 144008, to issue a new license to Steven Dinkowitz for SJR, Inc. / DBA The Backyard, located at 26509 Golden Valley Road, Santa Clarita, CA 91350 in the Fifth District. (17-0812)

**Nicole Love, Treasurer and Tax Collector's Office (TTC), reported on the application for Entertainment - General/SC, to issue a new license to Steven Dinkowitz for SJR, Inc./DBA The Backyard and noted the applicant has obtained all the necessary County approvals. TTC had no objection to the issuance of a new license.**

**Steven Dinkowitz, owner of the business, reported the hours of operation are from 8:00 a.m. to 10:00 p.m., Monday to Friday. Some Saturdays and Sundays they open until midnight, but that occurs mainly during summer months. On weekends, there will be entertainment such as jazz music, a cover band with some amplified music. There is no stage or dressing room. They do not plan on hosting special events. The business is located in a commercial area, occupying 2,600 square feet inside and 20,000 square feet with an outside patio, which is 2 miles away from residences and churches. So far, there are 20 employees as this is only their fifth week in business.**
