**President Renée Campbell called the meeting to order at 9:05 a.m. followed by a Pledge of Allegiance led by Secretary Genevieve Morrill.**

**II. PUBLIC HEARINGS**

2. Hearing on application for Partnership Change w/Hearing/SC, Business License ID# 143557, to issue a new license to Hui Wang for Forest Health Spa, located at 18838 Soledad Canyon Road, Santa Clarita, CA 91351, in the Fifth District. (18-0249)

**Nicole Love, Treasurer and Tax Collector's Office (TTC), reported on the application for partnership change for Hui Wang of Forest Health Spa and noted the applicant has obtained all the necessary County approvals. TTC had no objection to the issuance of a new license.**

In response to questions posed by the Commission, Wenting (Max) Wang, translator for Hui Wang, owner of the business, reported the business offers foot massages, body massages and a combination of foot and body massages. The hours of operation are from 10:00 a.m. to 9:30 p.m. from Monday to Sunday. The menu with prices of services was submitted as Exhibit "A". Pictures of the business establishment were on file for review.

During further discussion, Hui Wang responded that he was added as a partner in order to facilitate the business whenever Danna Xiong, the current owner, was not available. Vice President Sara Vasquez noted the application for partnership change was incomplete and questioned why the owner's name was not on the application.

Eric Barnes, TTC, stated Ms. Xiong submitted a fictitious business name statement showing both their names but it was not included with the paperwork. Nicole Love, TTC, stated Ms. Xiong was advised to attend the public hearing yet she was not present.

After further discussion, Vice President Vasquez informed the applicant that both he and Danna Xiong would need to be present at the hearing in order to confirm the requested change and clarify additional questions posed by the Commission, since there is no written evidence of the authorization. She also requested Mr. Wang work with TTC to correct their application prior to the meeting, submit a copy authorizing the partnership.

Therefore, on motion of Vice President Sara Vasquez, seconded by Commissioner Priscilla Cheng, and unanimously carried, this item was continued no later than January 31, 2018, to allow both applicants an opportunity to attend the meeting and complete paperwork amendment by the following vote:
