4. Report by Adolfo Gonzales, Chief Probation Officer. (21-1148)

Brandon Nichols, Chief Deputy Probation Officer, introduced himself and provided a brief overview of his training and experience. Mr. Nichols conveyed that he will serve as the primary contact for the Los Angeles Probation Oversight Commission (POC) and reported on the following:

- **The three main branches in the Probation Department: Adult Services, Juvenile Services and the Central Administrative branch;**
- **Statistics on the number of cases handled by the Probation Department;**
- **Locations of active juvenile halls, camps and area offices in Los Angeles County; and**
- **A general overview of the department's staffing, budget and its priorities.**

Kruti Parekh and Oscar Canales addressed the POC.

In response to questions posed by the POC, Mr. Nichols commented that the Probation Department has worked with the juvenile courts to release certain categories of youth from the camps and halls, which has resulted in a population decrease. Mr. Nichols noted that he could provide an update at a future meeting on the specific protocols and which categories of youth have been diverted.

In addition, Mr. Nichols provided statistics about the current number of employees for juveniles, adults, and number of vacancies. He also highlighted that he would obtain additional information to clarify whether staffing had been downsized, as the number of current employees reported show a decrease since October 2020. Further, he provided brief comments that the County is preparing for the population of youth that are being transferred from the Division of Juvenile Justice (DJJ) back into the County; and concluded that they are assessing various possibilities in preparation for their return.

Mr. Nichols responded to Commissioner Carrillo in relation to where DJJ youth will be placed noting that this is under active discussion, and presently a location has not been determined.

8. Discussion and take appropriate action pertaining to the education of youth in Probation halls, camps, and Los Angeles County Office of Education community schools.

Members of the Education Justice Coalition presented a PowerPoint presentation to discuss: the importance of education; how the role of the Probation Department and education are linked together; and, the role of the Los Angeles Probation Oversight Commission (POC) in ensuring that youth in the halls and camps are set up to succeed in their lives through education. During the presentation, Mainor Xucanx and Kevin Rodas also provided personal accounts of their educational experience as a youth in juvenile facilities.

Stephanie Horwitz, National Center for Youth Law, shared that a complaint from the California Attorney General's Office, that led to a recent settlement with the Los Angeles County Office of Education (LACOE), found deficiencies regarding the conditions of confinement of youth in juvenile detention facilities and inadequate educational services to justice involved youth.

Alaina Moonves-Leb, Alliance for Children's Rights, provided recommendations to the POC of actions they can take, which include making education one of the POC's priorities, agendaizing education as a standing item or creating a standing committee.

Following the presentation of the Education Justice Coalition, Dr. Debra Duardo, Superintendent of LACOE, introduced herself and members of LACOE. Dr. Duardo provided a brief overview of her experience and gave a presentation on the online educational platform that was created to provide direct live instruction to students in the camps and halls. Maricela Ramirez, Chief Education Officer, shared stakeholder feedback, which included parents, students, Probation, LACOE staff and community partners. Ms. Ramirez shared that feedback from surveys and focus groups conducted in July and August of 2020 showed that stakeholders felt that juvenile facilities are in need of improved technology, technology training, more instructional time, and enhanced one-on-one support.

Dr. Jason Hasty, Executive Director of Educational Programs, presented LACOE's current virtual instruction process and data showing distance learning participation; and talked about student counseling support. In conclusion, he highlighted a list of groups and measures that monitor and provide oversight of LACOE's actions.

Milinda Kakani, Oscar Canales, Jael Ovalle, Fernando Ruiz, Nicole Brown and Kruti Parekh addressed the POC.

Discussion ensued that education should continue to be a subject of discussion beyond this meeting; and it was noted that previously Commissioner Dupuy volunteered to take a co-leadership role in further investigation of LACOE's education of youth in juvenile facilities. (Commissioner Esché L. Jackson left the meeting at 2:25 p.m.)
