**I.     ADMINISTRATIVE MATTERS**

1. Call to Order and Roll Call.

**Chair Franky Carrillo called the meeting to order at 9:00 a.m. Wendelyn Julien, Executive Director conducted the roll call:**

**Ms. Julien stated that future elections will take place at the POC's annual meeting in January of each year and that commissioners elected to officer positions at this meeting will serve until January 2023. She opened the floor for the nominees for Chair, Vice Chair, and Secretary share their comments.**

**Rose Montelongo, Thomas Bell, and Louise Dodson addressed the POC.**

**Ms. Julien called the roll for Commissioners to cast their votes for the position of Chair. Commissioners Canales, Carrillo, Garcia-Leys, Jackson, Lewis, Meredith, and Nong cast their votes for Commissioner Carrillo. Commissioner Yamashiro cast his vote for himself, and Commissioner Dupuy abstained from voting.**

**By Common Consent, there being no objection, the POC elected Commissioner Carrillo for Chair of the POC.**

**Commissioner Yamashiro withdrew from the election for Vice Chair. Ms. Julien called the roll for Commissioners to cast their votes for the position of Vice Chair. Commissioners Canales, Carrillo, Dupuy, Garcia-Leys, Jackson, Lewis, Meredith, Nong, and Yamashiro cast their votes for Commissioner Jackson.**

**By Common Consent, there being no objection, the POC elected Commissioner Jackson for Vice Chair of the POC.**

**Ms. Julien called the roll for Commissioners to cast their votes for the position of Secretary. Commissioners Canales, Carrillo, Dupuy, Garcia-Leys, Jackson, Lewis, Meredith, Nong, and Yamashiro cast their votes for Commissioner Canales.**

**By Common Consent, there being no objection, the POC elected Commissioner Canales for Secretary of the POC.**

**Commissioners Samuel Lewis and Vice Chair Esché L. Jackson left the meeting.**

**The meeting reconvened at 11:30 a.m.**

## II. DISCUSSIONS

4. Discuss and take appropriate action on the meeting frequency of the Los Angeles Probation Oversight Commission.

- Franky Carrillo, Commission Chair, Los Angeles Probation Oversight Commission

**Chair Carrillo explained the rationale for returning to a two-meeting per month schedule in order to continue momentum and address the many issues facing the POC.**

**James Maddox addressed the POC.**

**Ms. Julien stated that the POC is following the Board of Supervisors' lead in conducting virtual meetings while California is remains in a state of emergency as declared by the Governor. Ms. Danielle Vappie added that the decision to return to in person meetings is dependent upon Assembly Bill (AB) 361.**

**Commissioner Meredith and Commissioner Yamashiro shared insights on the meeting frequencies and locations of the previous Probation Commission. Commissioner Meredith emphasized the benefit of meeting at the Hall of Administration for Justice Deputies.**

**Commissioner Garcia-Leys expressed support for one commission meeting per month.**

**Ms. Julien responded to Commissioner Dupuy's inquiry by mentioning that after the Brown Act is fully reinstated, the POC can continue to hold town hall meetings virtually with less than a quorum of commissioners. Regular and special meetings can be attended virtually by commissioners only if the address of the physical location where they are attending is included with the posted agenda and allows members of the public to attend at that location and provide public comment.**

**Chair Carrillo proposed a motion seconded by Commissioner Meredith to change the frequency of the regular POC meetings to the second and fourth Thursday of each month from 12:00 p.m. – 2:00 p.m.**

**Commissioner Nong amended the motion to make the meeting duration two and a half hours.**

**On motion of Chair Carrillo, seconded by Commissioner Dupuy, and duly carried by the following vote (Commissioner Samuel Lewis and Vice Chair Esché L. Jackson being absent), the Los Angeles Probation Oversight Commission approved the motion to change the frequency of the regular POC meetings to the second and fourth Thursday of each month from 12:00 p.m. – 2:30 p.m. as amended:**

5. Discuss and take appropriate action on progress the Los Angeles County Probation Department has made within the last two quarters towards compliance with the DOJ Settlement.
  - Eric Bates, Assistant Inspector General, Los Angeles County Office of the Inspector General

**Mr. Bates explained that the Department of Justice (DOJ) tasked the Los Angeles County Office of the Inspector General (OIG) with providing oversight to the Probation Department to ensure compliance with the DOJ Settlement. He shared that policy changes within the Probation Department require data systems so that data can be reviewed and analyzed. Mr. Bates mentioned that formal reports of OIG's findings and observations will be generated at a later time and shared. However, he provided updates on reviewing the Oleoresin Capsicum (OC) Spray decontamination policies, assessing Probation's training needs, accurately reporting uses of force, determining sufficient camera coverage and usage at facilities, tracking room confinement and the notification process to superintendents, complying with the Prison Rape Elimination Act (PREA), ensuring access to programming and effective documentation of youth who decline program participation, revising the Probation Department's grievance policy, and researching reasons for the abrupt move of youth from Central Juvenile Hall to Barry J. Nidorf Juvenile Hall.**

**The OIG observed substantial compliance with the DOJ Settlement and are working closely with the Probation Department to get to full compliance.**

**Jael Ovalle and Rose Montelongo addressed the POC.**

**Mr. Bettino shared that the Probation Department has been partnering with OIG to deliver requested information. He added that the use of force policy has been approved by the DOJ monitor, reviewed by Employee Relations, and will be sent to Probation's labor partners for final review. Despite the staff shortages, Mr. Bettino explained that the staff being deployed to juvenile halls are trained in de-escalation.**

**In response to Chair Carrillo's inquiry, Mr. Bettino stated that there have been minimal delays in relaying information to the OIG but information such as information in the Probation Electronic Medical Record System is withheld.**

**Commissioner Nong inquired about a timeline in implementing the use of force policy. Mr. Bettino explained the contractual timeline for implementation is thirty days, but ideally the Probation Department would like to train staff on the new policy before officially implementing the use of force policy.**

6. Discuss and take appropriate action on adult services provided by the Los Angeles County Probation Department's Special Enforcement Operations Unit (SEO) and Assembly Bill 109 services.
  - Karen Fletcher, Chief Deputy, Los Angeles County Probation Department
  - Howard Wong, Deputy Director, Los Angeles County Probation Department

Mr. Wong gave a presentation explaining AB 109 and the functions of the SEO.

No members of the public commented on this item.

Mr. Wong responded to Commissioner Dupuy's question by stating that the data broken down by race is reflected in the PowerPoint Presentation. He also mentioned that the resetting of time requires supervisors and director approval, but further research will be conducted to analyze the percentage of violations processed by case managers.

Commissioner Dupuy inquired about how the Probation Department handles cases where searches were conducted without a warrant and nothing was found, and how those individuals are remedied. Mr. Wong explained that individuals under supervision are informed of the requirements under AB 109 and provided a pre-release packet, but conditions while under supervision are not tracked.

Ms. Fletcher added that any law enforcement agency can conduct searches, but the Probation Department likes to conduct their own searches to maintain respect and positive rapport with the clients gained over time.

Commissioner Garcia-Leys urged the POC to look critically at when state violence such as searches, and violations is necessary.

Commissioner Yamashiro asked that the underlying data used to construct the bars and graphs in the PowerPoint Presentation be provided to the POC.

By Common Consent, there being no objection (Commissioner Samuel Lewis and Vice Chair Esché L. Jackson being absent), the POC accepted Mr. Wong's presentation.

7. Discuss and take appropriate action on progress the Los Angeles County Probation Department has made towards implementing the *L.A. Model* pursuant to the September 21, 2021 Board of Supervisors' motion regarding reaffirming and expanding the *L.A. Model* and plans to place the youth designated as Secure Track Youth at Campus Kilpatrick and Camp Joseph Scott.

Ms. Julien reiterated Los Angeles County Probation Department Chief Adolfo Gonzales' comment that a plan to move youth is underway based on the results of their multi-disciplinary team (MDT) meetings and adequate staffing at Campus Kilpatrick. She also highlighted that programming is a key element the Juvenile Justice Coordinating Council-Juvenile Justice Realignment Block Grant Subcommittee (JJCC-JJRBG) is considering.

Mr. Adam Bettino, Chief Deputy of the Los Angeles County Probation Department, stated that the Probation Department is working with an architect to compose a plan, which must be vetted by the JJCC-JJRBG Subcommittee. He mentioned that infrastructure questions, specifically at Camp Scott, would be discussed at the next Commission meeting.

Diana Velasquez and Jael Ovalle addressed the POC.

Commissioner Meredith emphasized that the youth on the secure track need structure and programming.

Commissioner Garcia-Leys expressed that the Programs and Services Ad Hoc Committee wants to be as helpful as possible in ensuring that educational programs are in place.

### III. REPORTS

8. Report from the Los Angeles County Probation Department on the move from Central Juvenile Hall (CJH) to Barry J. Nidorf Juvenile Hall (BJNJH) and the California Board of State and Community Corrections' (BSCC) findings and corrective actions at both CJH and BJNJH.

- Los Angeles County Probation Department

Chief Gonzales stressed that systemic organizational change takes time and should be approached proactively, not reactively. He mentioned that the Probation Department is evaluating ways to enhance their services within the facilities and has started by changing the leadership. Chief Gonzales explained the hiring process, emphasized the need for training new managers on Probation operations and Title 15 regulations. He explained that CJH was temporarily closed on March 10, 2022 and that repairs and renovations at CJH are underway. Chief Gonzales reported that he expects a small number of secure track youth to be moved from BJNJH to Campus Kilpatrick beginning the week of May 1, 2022.

Ms. Fletcher stated that the Probation Department is working diligently to ensure that the facilities are in compliance with the Title 15 regulations in order to be found suitable by the BSCC and to be in compliance with the DOJ Settlement agreement. She expressed that ultimately, the goal is facilities that meet the needs of the youth and families.

Brian Thompson, Mainor Xuncax, Milinda Kakani, Zoe Rawson, Matt Weber, Betty Fang, Thomas Bell, Elida Ledesma addressed the POC.

Wende added that Commissioners and staff have visited BJNJH several times since the closure of CJH for unannounced and announced visits.

Commissioner Canales' inquired about POC Commissioners' involvement in the Probation Department's hiring process. Ms. Fletcher confirmed that POC Commissioners were on the interview panels but were omitted from subsequent hiring steps due to human resources regulations and county policies. She reiterated the vetting process with the CEO, County Counsel, and the Board offices.

Vice Chair Jackson shared her observations when she visited BJNJH to distinguish how the programming and services differed between the boys and the girls. Vice Chair Jackson inquired about how the youth, staff, parents, and county stakeholders were notified about the move of youth from CJH to BJNJH. In response, Chief Gonzales stated that the decision was made quickly, impacting the planning and notification process. He mentioned that different staff were assigned to notify the upcoming shifts that same day and parents were notified after the move was completed for safety reasons. Ms. Fletcher added that some parents were notified while in route and others were notified once the

youth arrived at BJNJH. She explained that the notifications methods included email and telephone. Ms. Fletcher mentioned that the Probation Department had originally planned to begin the gradual movement of youth from CJH to BJNJH on Monday, March 14, 2022. She explained this plan was accelerated due to updates from the BSCC outlined in a letter.

In response to Vice Chair Jackson's inquiry, Chief Gonzales mentioned that a risk assessment and preventative measures would be considered to aid the review and investigative teams when incidents occur. Chief Gonzales stressed the importance of providing safety and security for all, therefore, the Probation Department is dedicated to this reform.

Commissioner Garcia-Leys sought clarification on why youth were moved so abruptly. Chief Gonzales explained Probation sent a letter to the BSCC requesting approval to suspend operations and delay the inspection of CJH. Chief Gonzales stated that the BSCC informed the department of a planned inspection beginning March 14, 2022. Based on an internal audit by the Probation Department, he stated that Probation leadership determined that CJH was out of compliance with at least one Title 15 requirement and made the decision to move the youth prior to the planned inspection. Ms. Fletcher further explained how the inspection process works and the steps Probation has taken in addressing areas of concern such as room confinement and shift changes.

Commissioner Yamashiro shared observations from his visit to CJH and provided his perspective of the consequences of the abrupt move of the youth. He urged the Probation Department to take responsibility and hold itself accountable for the physical, educational, and criminal harm being imposed upon youth and staff.

Commissioner Dupuy raised concerns about the Probation Department centering staff, youth, and families. She inquired about whether the staff or families were considered prior to the new leadership assignments given previous problems. Chief Gonzales reiterated that the moves and promotions were vetted through County Counsel and the Department of Human Resources. To instill confidence in the new leadership team, Chief Gonzales stated that the department can monitor, provide input and feedback, conduct evaluations, and establish a set of expectations. Commissioner Dupuy urged the Probation Department to work with the POC to ensure that the wellbeing of staff and youth are being centered.

Commissioner Nong inquired about the plan for moving youth prior to March 12, 2022. Chief Gonzales stated that the Probation Department was planning a phased approach to move the youth out of CJH by first bringing in new leadership, training staff, performing necessary repairs, and integrating the BSCC's technical assistance to support the staff. Ms. Fletcher added that the corrective action plan was submitted to the BSCC on March 10, 2022, with a notification from BSCC on March 11, 2022, stating that CJH would be inspected if any youth were in the facility. Ms. Fletcher stated that youth would be phased back into CJH as repairs are completed.

Commissioner Meredith shared feedback from his visit too BJNJH regarding the perspectives of youth and staff who share the sentiment that the instability within the facility is causing fear.

Commissioner Canales asked about programming at BJNJH. Ms. Fletcher clarified that there is some programming, but efforts are underway to identify programs and services that would better meet the needs of the youth. She also noted that most of the violent attacks she referenced are youth on youth assaults, but there are also incidents of youth

on staff cases, all of which are reviewed by on-site critical incident review committees, supervisors, and directors.

Mr. Bettino replied to Commissioner Lewis' question by stating that the JJCC-JJRBG Subcommittee is having conversations with partners and advocacy groups to finalize the criteria for the Transitional Multidisciplinary Teams (T-MDTs). Commissioner Lewis expressed the effects that staffing directly has on the youth and their programming based on his observations.

Commissioner Nong proposed a motion to instruct the POC to request all documents including communications to staff, youth, families, LACOE, and any other parties related to the decision to close Central Juvenile Hall and any plans that were developed in preparation for this transition from the Los Angeles County Probation Department.

On motion by Commissioner Nong, seconded by Vice Chair Jackson, unanimously carried, the Los Angeles Probation Oversight Commission approved the POC to request all related documents and correspondence about the preparation and movement of youth from CJH to BJNH from the Probation Department:

On motion by Commissioner Nong, seconded by Vice Chair Jackson, unanimously carried, the Los Angeles Probation Oversight Commission approved the POC to instruct the Los Angeles County Probation Department to deliver all plans related to the transition of youth and staff back to CJH on a rolling basis prior to any movement taking place:
