Chairperson Clayton Johnson formerly welcomed Commissioner Joahanna Terrones to the SBC. Commissioner Terrones gave a self-introduction and thanked everyone for the warm welcome.

Chairperson Clayton Johnson and Vice Chairperson Sherman held a discussion on the language of the 2023 SBC strategic goals.

And the SBC made the following amendments to the 2023 SBC strategic goals:

- 2. Monitoring quality of access, treatment, and outcomes related to medical care and mental health care.
  - a. Underlying causes of in-custody deaths deemed natural by the Medical Examiner.
  - a. Regular meetings with DHS, CHS
  - b. Monitor mental health patient rights and access to mental health services
- 3. Seeking feedback and making recommendations to the Board of Supervisors on areas of concern regarding the closure of MCJ and implementation of the Care First, Jail Last plan as it impacts jail conditions and community capacity.

**4.** Discussion of Rights of Mental Health Patients in County Jails. (23-0396)

Chairperson Clayton Johnson shared that this is a follow up on data requested from the Los Angeles Sheriff's Department, LASD regarding the use of force on people with mental disabilities at the jails. And that Commander Macias did send him data on the use of force incidences in 2022 for Twin Towers, TT and Pitches North, however there was a lack of or no clear reason why there was not data on Men's Central Jail, MCJ. Commander Macias, LASD did state in an email that "the number of incidences at MCJ for people who are in medium observation was difficult to ascertain with any certainty with limited housing on the latter part of the year". And that the LASD is working with the CEO and CIO to get a clearer data management system. Lastly that he would be following up with Commander Macias for an update on MCJ.

Vice Chairperson Sherman stated that he repeatedly visited 5000 during the course of 2022. And subsequent to the use of force incident that he was told that over the span of that year that things were intensifying between the incarcerated people and the deputies administering that floor. And deputies reported that fights are common in 5000 and that there isn't any diligent record keeping at the LASD. He then explained why he included the attached report. And that although the report is not specific to LA County, he felt that this is an opportunity to engage with Department of Mental Health's (DMH), Patient Rights Advocate (PRA) team to inquire if they have faced any of the challenges documented in the report. He also stated that the incarcerated people receiving mental health care in the jails have the right to a PRA.

Commissioner Miller stated it would be helpful if they can get clarity from Correctional Health Services, CHS on their thoughts on the relationship between overcrowding and mental health and isolation and mental health?

Commissioner Sherman stated that LA County PRA team reports to DMH. He emphasized that the SBC appears to be filling this gap and is likely not the best to fill it and possibly DMH isn't either. Lastly, he stated that it is important they engage with the DMH about PRAs.

- Palmdale Sheriff's Station, 750 E Ave Q, Palmdale, CA. 93550, January 17, 2023

Please note that the Lancaster Station did not have hot running water, people being held did not have any clarity on the process and how long they will be there or their court date. Overall, they left with a lot of questions and curiosities.
