Briefing on structure, activities and recent focus of e-Government Advisory Committee

Richard Sanchez, Chief Information Officer
Chief Information Office (13-5129)

At the request of Chairperson Fuhrman, Richard Sanchez, Chief Information Officer (CIO), shared a collection of the CIO's Key Initiative for 2014, which highlighted the following:

Mr. Sanchez advised the Commission that if some of the areas are chosen, the Commission's assistance will be needed to prepare recommendations to be submitted to the Board of Supervisors.

7. Information Security Update.

Robert Pittman, Chief Information Security Officer

Chief Information Office (13-5134)

Robert Pittman, MPA, CISM, Chief Information Security Officer (CISO), CIO, introduced Mr. Jeff Zito, Assistant CISO, as a new member of the team. Mr. Pittman highlighted seven key points from the Countywide information security program update, reporting that 13 policies have been revised due to the challenge of inconsistency. The revision defines terms for a more consistent use of language for all 13 policies.

Mr. Zito is currently working on revising the County Information Security Strategic Plan that consisted of 80 pages and now has been reduced to 25 pages with the flexibility to be updated annually. The book will be broken into four chapters: Program Update; Threat Management; Threat Intelligence; Appendix.

Mr. Pittman further stated that time and effort has been put into the threat intelligence (CCERT / Incident Response) and expertise has been gained from the District Attorney's office, as well as the high tech crime unit in terms of early warnings. The CIO has developed a strong working relationship with federal agencies in terms of becoming a Multi-State - Information Sharing Analysis Center (MS-ISAC) primary member.

Mr. Pittman also reported that the Web Application Firewall phase one has protected over 300 applications and phase two, the remediation code is still in progress. He further added that administratively the National Cyber Security Report was conducted by MS-ISAC; the adoption of two new job classifications, IT Security Specialist and IT Security Analyst; Departmental Information Security Officer (DISO) will be realigned from the Salary Step Management Appraisal Performance Program (MAPP); the Annual Security Recognition awards Program will be February 20, 2014; and he has been elected to serve a two-year term with the MS-ISAC Executive Committee.
