Call to Order. (15-2412)

Chairperson Montaña called the meeting to order at 10:02 a.m.

CA) on May 27, 2015. Although the facility was reported to be in satisfactory condition, there was concern that the facility needs more medical and mental health staff for safety. Additionally, the facility is still in need of a separate radio channel.

Following the report, Commissioner Goldberg inquired to know who handles the mental health issues. Staff will contact the representative from the Sheriff's Department and advise them to be prepared to provide answers to the inquiry during the SBC Business meeting in June. Commissioner Goldberg also inquired about the definition of the "Use of Force." Representatives from the Department of Children and Family Services and Probation Department will also be contacted to prepare to provide answers to the inquiry also during the SBC Business meeting in June.

 - **Toilets and sinks were clogged with debris**
 - **Toilet leaks water**
 - **Women's personal hygiene items were lying out**

Staff at this facility informed the Commissioners that a work order has been submitted for these and other items in March 2015 and months prior to March 2015. The Commissioners have requested that staff follow up with the Sheriff Department and report these findings to the party responsible for maintenance.
