**Louis Burns provided an update of the proposed fare increase set for Implementation, January 2016.**

**Commissioners Steve Miller, John James, Allan Buck, Rosa Maria Chaturvedi and 1st Vice President Janet Neal addressed their concerns regarding the fare rate change.**

**Daniel Garcia and Waya El, members of the public, addressed the Commission.**

4. Presentation by the Department of Public Social Services, on its responsibilities and/or direct services that substantially impact the lives of people with disabilities, as requested by the Commission.

**Silvia Valencia reported on California Work Opportunity and Responsibility to Kids (CalWORKS) Program. CalWORKS provides cash aid each month to eligible families with a child or a pregnant woman to help pay for housing, food and other necessary expenses. It also provides employment services and includes a disability deprivation criteria for parents with a physical and mental illness, when the illness reduces or eliminates the parent's ability to support or care for an eligible child.**

**The CalWORK GAIN Program provides employment-related services to CalWORKS Welfare-to-Work participants to help them find employment; stay employed; and move on to better jobs.**

**Regina Adkins-Williams reported on General Relief (GR) and Cash Program for Immigrants (CAPI). The GR cash service allocates \$221 per month to indigent adults who do not qualify for State or Federal public assistance programs. The program includes emergency temporary housing, Supplemental Security Income (SSI) advocacy service, and substance abuse treatment. There are housing subsidy referrals to assist homeless GR participants with rent up to \$500. The CAPI Program assists in three ways: (1) cash benefits to aged, blind, or disabled legal immigrants of 100% of the State-funded program; (2) grants that are \$10 less than SSI payment standard for an individual; (3) \$20 less for a couple. General Relief Opportunities for Work (GROW) Program provide welfare to work services for employable indigent adults, and disabled volunteers. GROW also provides mental health services at any time during the individual's nine-month GROW eligibility.**

**Estela Barrera reported on CalFresh Supplemental Nutrition Assistance Program (SNAP). CalFresh Nutrition Program is the first line of defense against hunger that promotes the general welfare and safeguards the health and well-being of low-income households by raising their level of nutrition. CalFresh participants purchase food using electronic benefit transfer cards. The Restaurant Meals Program (RMP) provides participants with a variety of low-cost prepared meal choices, improve the lives of elderly, disabled and homeless CalFresh participants to promote health eating habits.**

**Maria Magallanes reported on In-Home Supportive Services (IHSS) Program that help pay for basic in-home care services provided to aged, blind or disabled individuals so that they may remain safe in their own home. It is an alternative to out-of-home care such as nursing homes or board and care facilities. To receive IHSS, one must be 65 years of age or older, disabled, blind or have a disabled child. Provisions include housecleaning, meal preparation, laundry, grocery shopping, personal care services, protective supervision, and accompaniment to medical appointments. She explained that the Medi-Cal Program is a public insurance health care program which provides health care services for low-income individuals and families who meet defined eligibility requirements. It also includes outpatient services, maternity and newborn care, primary and specialty care, emergency and mental health services.**

**Charles Palmer provided an overview of the Civil Rights complaints process that include disability as a protected category which involves an investigation process, reporting and implementation of corrective actions.**

**President Carlos Benavides, 1st Vice President Janet Neal, 2nd Vice President Wendy Welt Narro, Commissioners Rosa Chaturvedi and Steve Miller provided comments about each program.**

**Daniel Garcia, Alexia Teran and Genevieve Clavreul, members of the public, addressed the Commission.**

**After their presentation, Silvia Valencia, Regina Adkins-Williams, Estela Barrera, Maria Magallanes and Charles Palmer responded to questions posed by the Commission and members of the public.**

**President Carlos Benavides thanked the speakers and requested the Department provide the Commission with a liaison who can address future concerns that may arise during Commission meetings.**

**Therefore, on motion of 1st Vice President Janet Neal, seconded by Commissioner Steve Miller, there being no objection, a Policy Committee was formed to review and develop an understanding of the impact of diminishing State funding on the lives of LA County residents with developmental disabilities. Commissioner Miller will lead this Committee and inform staff at a later date if the Policy Committee should remain a Standing Committee with his first meeting and those members that will be participating.**
