- 4. Presentation on the Los Angeles County's employment and gender statistics, by the Department of Human Resources; and compensation statistics report by the Chief Executive Office's compensation division. (Continued from the meeting of October 5, 2015)
 - Lisa Garrett, Director, Los Angeles County Department of Human Resources
 - Napoleon Valera and Susan Moomjean, Los Angeles County Chief Executive Office (15-4562)

Ms. Lisa Garrett Personnel Director, Los Angeles County Human Resources, introduced Mr. Napoleon Valera of the Chief Executive Office's Compensation Division. Ms. Garrett stated that the State of California is conducting an audit of a number of counties including Los Angeles and Santa Clara Counties and that the data may include information that the CW might find useful.

Mr. Napoleon Valera, Manager, Benefits and Compensation Division, Chief Executive Office, provided an overview of how Los Angeles County set the County's employee classification procedures. He stated that Los Angeles County has 97,000 employees, there are approximately 2,400 classifications, and 87 % of the employees are represented and 13 % non-represented. The County complies with the minimum wage provision and the classifications are approved by the Board of Supervisors. Classifications are set when a class is created and through labor negotiations.

The County conducts comparative analysis by utilizing both external and internal factors as well as private surveys purchased by the CEO which are used to compare Los Angeles County with the labor market and the top ten counties in California. The CEO ensures that these surveys are valid and accredited.

Ms. Garrett stated that DHR is working with the Chief Information Office on launching a pilot program that would attract women to go into positions that are dominated by males.

The CW will continue to work with DHR and the CEO on issues of mutual interest.
