 Casa Eperanza Treatment Center (Mcleod, Pomona, CA) on February 9, 2016.

Commissioners Andrews and Montaño visited:

- Optimist Boys Home and Ranch Main (Figueroa St., Los Angeles, CA) on February 4, 2016.
- Los Padrinos Juvenile Hall (Quill Dr., Downey, CA) on February 9, 2016.

During the reporting period, the following group facility was reported as being in unsatisfactory condition:

Chairperson Bigby and Commissioners Bhatia, Duran and Zhen visited:

- Men's Central Jail Section 3500 A-D (Bauchet St., Los Angeles, CA) on February 4, 2015 and reported the following:
 - The cells are dark.
 - The inmates complain that it is cold.
 - The vents, pipes and walls are rusted.
 - The walls need painting and the inside of the cells are narrow and very dirty.
 - County plumbers are constantly coming to fix plumbing issues.
 - The pipe room leaks water and the pipes leak behind the toilet and sinks.
 - A Deputy has had frequent asthma attacks and was out for a

i.e. bronchitis.

- Due to overcrowding there is not enough staff to evacuate inmates in an emergency situation.
- **5.** Report from Sybil Brand Commission's Ad-Hoc Committees. (16-0881)

Commissioner Zhen recommended that the Annual report Ad-Hoc committee report be continued to the February 24, 2016 meeting.

Commissioner Bhatia reported that the By law Ad-Hoc committee met and will draft a report for the Commissions review.
